Notice of Intention to Prepare a  
Development Plan**

The Planning Service, an Agency within the Department of the Environment, intends to prepare a development plan for the Magherafelt District Council Area, under the provisions of Part III of the Planning (Northern Ireland) Order 1991. The Plan will inform the general public, statutory authorities, developers and other interested bodies of the policy framework and land use proposals that will be used to guide development decisions within the District up to the year 2015.

The Plan will focus on a number of issues including: the zoning of land for particular forms of development such as housing, industry and recreation; designations relating to regional policies such as Green Belts; committed public sector proposals and designations of other site specific areas to which local policies will apply, such as local landscape policy areas. The Plan will also address the respective roles of the various settlements within the District taking account of the Draft Regional Strategic Framework for Northern Ireland, "Shaping Our Future".

The Department will consult Magherafelt District Council, Government Departments, statutory undertakers, other appropriate bodies and interested parties in the preparation of the Plan.

The Department is particularly anxious to ensure that members of the public have the opportunity to participate at this early stage in the Plan making process by contributing to the formulation of issues which the plan should consider.

Individuals and interested parties are therefore invited to submit representations in writing to the Divisional Planning Manager at the address below. Please note that any comments relating to specific sites should be accompanied by an up-to-date map clearly identifying the lands in question.

### **THE AFGHANISTAN (UNITED NATIONS SANCTIONS) ORDER 1999 (S.I. 1999/3133)**

On 12th April 2000, the Committee established by the United Nations Security Council in paragraph 6 of its resolution 1267 (1999) of 15th October, 1999 designated the funds and financial resources to be frozen by Member States for the purposes of paragraph 4(b) of that resolution as:

"Any financial assets and economic benefits of any kind, including funds derived or generated from property owned or controlled directly or indirectly by the Taliban, or by any undertaking owned or controlled by the Taliban. They include, but are not limited to: cash; cheques, drafts, money orders and other payment instruments; deposits with financial institutions or other entities, balances on accounts, debts and debt obligations; publicly and privately traded securities and debt instruments, including stocks and shares, certificates representing securities, bonds, notes, warrants, debentures, derivatives contracts; interest, dividends or other income on or value accruing from or generated by assets; credit rights of set-off, guarantees, performance bonds or other financial commitments; letters of credit, bills of lading, bills of sale; documents evidencing an interest in funds or financial resources."

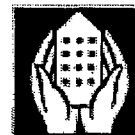
## **Department of Finance and Personnel**
