### Roads (Speed Limit) (No. 2) Order (NI) 2000

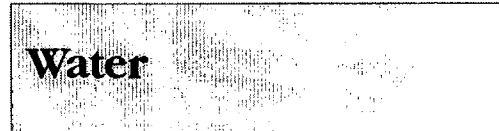
