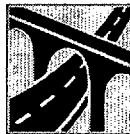

ROADS Service

Notice is given that the Department for Regional Development made on 18th September 2000 the following Orders, which will come into operation on 9th October 2000 —

the Parking Places on Roads (Amendment No. 3) Order (Northern Ireland) 2000 (S.R. 2000 No. 271). The Order authorises as parking places the parking places specified in Schedule 1 (which are for the use of disabled persons' vehicles only); authorises the removal of the parking places specified in Schedule 2; redesignates the existing parking places specified in Schedule 3; and redesignates and deletes descriptions of existing parking places in Newtownards. The redesignations and deletions will not affect the locations of the parking places.


the Control of Traffic (Antrim) Order (Northern Ireland) 2000 (S.R. 2000 No. 272). The effect of the Order is to prohibit the use by vehicles other than buses of the most northerly road linking Steeple Road, Antrim and Old Steeple Road, and to restrict the direction of travel of buses using that link road.

the Control of Traffic (Ballynahinch) (Amendment) Order (Northern Ireland) 2000 (S.R. 2000 No. 273). The Order makes permanent the one-way traffic system operating in part of The Square, Ballynahinch, and amends the description of that part of High Street, Ballynahinch in which there is a one-way system of traffic.

the Cycle Tracks (Newcastle) Order (Northern Ireland) 2000 (S.R. 2000 No. 274). The effect of the Order is to introduce cycle tracks on lengths of both footways of Dundrum Road and the north-eastern footway of Railway Street, Newcastle.

(3) To encourage the efficient and economic operation of the Licensee's system by providing incentives for suppliers not to hold capacity in excess of their requirements.

(4) To provide clarity as to the costs to be charged by the Licensee to suppliers by way of Licensee Unpredictable Operating Costs.

(B) Effects

(1) The deletion of the provisions for capacity overrun charges.

(2) The introduction of a penalty charge to be levied on suppliers who fail to reduce the amount of gas which they are flowing on an interruptible basis in line the requirements of a flow order issued by the Licensee to deal with system constraints.

(3) The amendment of the capacity element of the exit charge so that charges are levied on the basis of the total firm capacity held by a supplier in any given month, rather than by reference to the peak day capacity booked by that supplier in the month in question.

(4) The addition of provisions enabling the Licensee's Network Code to specify charges as Licensee Unpredictable Operating Costs to the extent that those charges also fulfil the general requirements for Licensee Unpredictable Operating Costs.

2.2 Modifications to Condition 2.3

(1) To facilitate the efficient and co-ordinated operation of the Licensee's system by enabling due consideration to be given to the views of all users of the Licensee's system when reviewing the Licensee's Network Code.

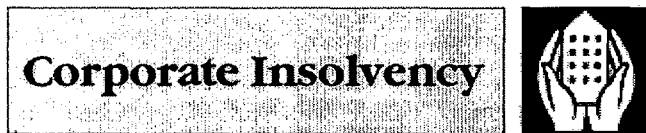
