## Proclamation by the Secretary of State

### 19th March 2001 - Bank Holiday

The Rt. Hon. Peter Mandelson MP, Secretary of State for Northern Ireland, in pursuance of the powers conferred on him by the Banking and Financial Dealings Act 1971, has signed an Order appointing Monday, 19th March, 2001, as a Bank Holiday in Northern Ireland. The Proclamation of a Bank Holiday directly affects only the banks and other financial institutions. Any questions of a holiday on 19th March, in other sectors of commerce and industry will be a matter for the individual firm to decide, taking into account its past practice in relation to Bank Holidays.

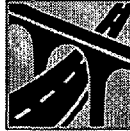

#### Strabane Bypass Stage 2 In The Townlands Of Ballycolman, Castletown, Magirr And Town Parks Of Strabane County Of Tyrone

The Department for Regional Development having considered the matters set out in Article 67A(7) of the Roads (Northern Ireland) Order 1993 hereby gives notice in accordance with the provisions of Article 67A(8) and (9) of its intention to proceed with the proposed Strabane Bypass Stage 2 road project.

The general effect of the project will be to provide 2.65 km of new single carriageway road from a point on the present trunk road at its junction with the U4010 Strathmore Drive and extending in a generally northerly direction to join the A5 at Bradley Way. New roundabouts will be constructed where the Bypass joins the existing network. Other junctions will be provided where the new route crosses Orchard Road, Strahans Road and Urney Road.

#### The Belfast - Larne Trunk Road T9 In The Townlands Of Ballyearl, Carntall, Lisnalinchy, Legaloy, Skilganaban, Dunturky, Toberdowney, Castletown, Lismenary, Lealies, Drumnahoe, Glebe, Ballyloran, Antiville County Of Antrim

The Department for Regional Development having considered the matters set out in Article 67A (7) of the Roads (Northern Ireland) Order 1993 hereby gives notice in accordance with the provisions of Article 67A(8) and (9) of its intention to proceed with the proposed Belfast-Larne Trunk Road T9 project.

The general effect of the project will be -

- 1) To reconstruct 2.2 kilometres of the existing T9 route to dual carriageway standard from a point south of the B59 Doagh Road at Ballyearl to a point north of the B95 Hillhead Road at Lisnalinchy.

The proposed new length of trunk road will consist of two 7.3 metre wide carriageways, a 2.5 metre wide central median and two 2.5 metre wide verges incorporating a 2 metre wide footway/pedestrian facility on the eastern side. Some modification will be made to connecting routes and two new roundabouts will be constructed at the junctions with B59 Doagh Road and B95 Hillhead Road;

- 2) To construct a climbing lane extending in a southerly direction for a distance of 1.1 kilometres from the A57 Templepatrick Road junction at Dunturky and a climbing lane extending in a northerly direction for a distance of 1.2 kilometres from a point 200 metres north of the junction with the U56 Lismenary Road at Toberdowney.

The proposed new lengths of climbing lanes will consist of 3.2 metre wide carriageways together with 3.5 metre wide verges and a new roundabout will be constructed at the junction with the A57 Templepatrick Road with a link road to the B58 Carrickfergus Road. In addition the Department proposes to introduce speed reduction measures at Ballynure.

- 3) To construct two new roundabouts at Millbrook and Antiville.

The project will implement the first phase of a strategy for the T9 which is ultimately to provide a dual carriageway from the M2 to Larne.
