Pursuant to Section 139(6) of the Customs and Excise Management Act 1979 and paragraph (1) of the Schedule 3 thereto, the Commissioners of Customs and Excise hereby give you notice that, by virtue of the powers contained in the Customs and Excise Management Act 1979 and enactments amending that Act, the aforesaid goods have been seized as liable to forfeiture upon the grounds that:

The Skeoge Link 2, Londonderry In The Townlands Of Ballynagalliagh And Coshquin County Of Londonderry

The Department for Regional Development having considered the matters set out in Article 67A(7) of the Roads (Northern Ireland) Order 1993 hereby gives notice in accordance with the provisions of Article 67A(8) and (9) of its intention to proceed with the proposed Skeoge Link 2 road project.

The general effect of the project will be to construct 1.95 kilometres of a new carriageway from Buncrana Road (north west of Whitehouse Road) to interface with the works previously completed in the Skeoge 1 scheme (170 metres east of Lower Galliagh Road). The proposed new length of road will consist of a 9.3 metre wide carriageway (including 1.0 metre hardstrips) two 5.0 metre wide verges incorporating 3.5 metre wide cycle/pedestrian facilities. Some modification will be made to connecting routes.

In addition to the earthworks and drainage, landscaping will be carried out to improve the appearance of the route and lessen the visual impact of the project. The aim of the project is to improve conditions for road users by reducing journey times for vehicular traffic and improving pedestrian/cycle safety and access.



The effect of the Order is to create a with-flow bus lane in which cycles are permitted between 7.30 a.m. and 9.30 a.m. from Monday to Friday on part of the citybound section of the carriageway of Kingsway, Dunmurry, between a point approximately 38 metres north-east of its junction with Upper Dunmurry Lane, and a point approximately 260 metres north-east of that junction.

PETROLEUM ACT 1998

Northern Ireland Court Service

Notice is hereby given that the Lord Chief Justice of Northern Ireland, in exercise of the powers conferred on him by sections 19(5) and 22(3) of, and Schedule 3 to, the Nurses Midwives and Health Visitors Act 1997 and of all other powers enabling him in that behalf, hereby approve the Nurses, Midwives and Health Visitors (Professional Conduct) (Amendment)(No. 2) Rules 2002, made by the United Kingdom Central Council for Nursing, Midwifery and Health Visiting.

The Nurses, Midwives and Health Visitors (Professional Conduct) (Amendment) (No. 2) Rules 2002, Approval Order (Northern Ireland) 2002

This Order approves, as respects proceedings in Northern Ireland only, the Rules set out in the Schedule. These amend the Professional Conduct rules of the United Kingdom Central Council for Nursing, Midwifery and Health Visiting so as to reduce the number of medical examiners who are required to examine the practitioner from two to one in cases

concerning the practitioner's fitness to practice; and to make further provision with respect to any practitioner instructed by the practitioner. Northern Ireland Office

The Secretary of State, in pursuance of Sections 1(4A) and 3 of the Explosives Act (Northern Ireland) 1970 has made the Explosives (Fireworks) Regulations (Northern Ireland) 2002

These Regulations repeal previous Regulations which are largely re-enacted and make provisions to prohibit the possession, purchase, sale, acquisition, handling or use of certain categories of fireworks except under licence, issued by the Secretary of State to whom application shall be made in writing. A licence fee will be payable (regulations 4, 5, 6, 7 and 10). Fireworks exempt from the general prohibition are described (regulation 9 and Schedule 1).

The regulations now prohibit the possession, purchase, sale, acquisition, handling or use of all but one class of firework except under licence from the Secretary of State.

The Regulations prohibit the possession, purchase, sale, acquisition, handling or use of fireworks of erratic flight, mini-rockets, bangers or certain air bombs but provide an exception for any person for use, in the course of a trade or business of his, for special effects purposes in the theatre, on film or on television (regulation 4 and 5).

The Regulations also require specified fireworks and assemblies to be marked with the words "This device must not be sold to, or used by, a member of the general public". Packets of sparklers must be marked with the words "Warning: not to be given to children under 5 years of age" (regulation 8).

The Regulations provide a sliding scale of fees for the issue of fireworks licences (regulation 10 and Schedule 3).

The Regulations come into force on 6th May, 2002.

Game Preservation (Amendment) Act (Northern Ireland) 2002: Commencement Order

The Department of the Environment has made a Commencement Order entitled Game Preservation (Amendment) (2002 Act) (Commencement) Order (Northern Ireland) 2002 (S.R. No. 130 (C.10)).

This order brings into operation on the 1st April 2002, sections 1 and 2 of the Game Preservation (Amendment) Act (Northern Ireland) 2002. The provisions brought into operation relate to functions of the Department of the Environment affecting regulation of close seasons periods for game-birds and certain other miscellaneous and general matters.

The principal change to the Game Preservation Act (Northern Ireland) 1928 as amended is the extension of the partridge shooting season to include September each year.

Maternity and Parental Leave etc. (Amendment No. 2) Regulations (Northern Ireland) 2002 – S.R. 2002 No. 135.

Notice is hereby given that the Department for Employment and Learning, in exercise of the powers conferred on it by Article 108(1), (2) and (5) of the Employment Rights (Northern Ireland) Order 1996 and of every other power enabling it in that behalf, has made a statutory rule entitled the Maternity and Parental Leave etc. (Amendment No. 2) Regulations (Northern Ireland) 2002 - S.R. 2002 No. 135.

The Regulations amend the provisions relating to parental leave in the Maternity and Parental Leave etc. Regulations (Northern Ireland) 1999 ("the Principal Regulations") (S.R. 1999 No. 471), which implement in Northern Ireland Council Directive 96/34/EC on the framework agreement on parental leave.

The Regulations revoke regulation 13(3) of the Principal Regulations, which restricted the right to parental leave so as to be exercisable only in respect of children born or placed for adoption on or after 15th December 1999. Regulation 15 of the Principal Regulations is amended to allow parents of children born or placed for adoption up to five years before that date the period up until 20th July 2005 in which to take parental leave (or up until the child's eighteenth birthday in the case of a child entitled to a disability living allowance).

A new regulation 13(1A) enables these parents to rely on a period of service with a previous employer in order to satisfy the one-year qualifying service requirement to which the right to take parental leave is subject. Schedule 2 to the Principal Regulations is amended to require parents seeking to take advantage of this provision to give their current employer notice of, and if the employer reasonably requires it, evidence of, the relevant period of service.

The Regulations also amend regulation 14 of the Principal Regulations to extend the period of leave to which a parent is entitled from thirteen to eighteen weeks in the case of a child who is entitled to a disability living allowance. Schedule 2 to the Principal Regulations is amended to require parents seeking to take advantage of this provision to give their current employer notice of, and if the employer reasonably requires it, evidence of, the relevant period of service.

Paragraph 4 of Schedule 2 to the Principal Regulations is amended to provide that the notice period in respect of parental leave required to be given to the employer by the employee is 21 days instead of thirteen weeks. Paragraph 6 of Schedule 2 is amended to provide that an employer may not postpone a period of parental leave in respect of a child beyond the date of the child's eighteenth birthday.

The Regulations come into operation on 21st April 2002.
