#### ***The Scottish Parliament (Letters Patent and Proclamations) Order 1999***

The following Letters Patent were signed by Her Majesty The Queen on the 16th December 2002 in respect of the **Debt Arrangement and Attachment (Scotland) Bill asp 17**.

ELIZABETH THE SECOND by the Grace of God of the United Kingdom of Great Britain and Northern Ireland and of Our other Realms and Territories Queen Head of the Commonwealth Defender of the Faith To Our trusty and well beloved the members of the Scottish Parliament GREETING:

FORASMUCH as a Bill has been passed by the Scottish Parliament and has been submitted to Us for Our Royal Assent by the Presiding Officer of the Scottish Parliament in accordance with the Scotland Act 1998 the short Title of which Bill is set forth in the Schedule hereto but that Bill by virtue of the Scotland Act 1998 does not become an Act of the Scottish Parliament nor have effect in the Law without Our Royal Assent signified by Letters Patent under Our Scottish Seal (that is Our Seal appointed by the Treaty of Union to be kept and used in Scotland in place of the Great Seal of Scotland) signed with Our own hand and recorded in the Register of the Great Seal We have therefore caused these Our Letters Patent to be made and have signed them and by them do give Our Royal Assent to that Bill COMMANDING ALSO the Keeper of Our Scottish Seal to seal these Our Letters with that Seal. IN WITNESS WHEREOF we have caused these Our Letters to be made Patent.

### Roads (NI) Order

#### Department of the Environment

The Department of the Environment has made a Statutory Rule entitled **Motor Vehicles Driving Licences (Driving Licences) (Amendment No. 2) Regulations (Northern Ireland) 2002** (S.R. 2002 No. 383).

These Regulations, which come into operation on 6th January 2003, replace the theory test currently taken by those wishing to obtain a driving licence with a two-part theory test. Part I of the new two-part theory test consists of the old theory test, consisting of a test of driving theory. Part II consists of a test of the candidate's ability to recognise hazards to driving (a "hazard perception test").

The fee for a theory test in respect of any category of motor vehicle is increased from £18 to £20.50.

### Department for Regional Development

The Department for Regional Development has today made a statutory Rule entitled the Londonderry Port and Harbour (Variation of Pilotage Limits) Order (Northern Ireland) 2002.

The Order confers the following powers on the Londonderry Port and Harbour Commissioners-

By virtue of Section 7(5) of the Pilotage Act 1987 a direction given by a competent harbour authority for the purpose of making pilotage compulsory for ships navigating in a specified area shall not apply to any area which is outside the authority's harbour unless the limits of jurisdiction of the authority for pilotage purposes has been extended to cover that area.

This Order accordingly extends the limits of jurisdiction of Londonderry Port and Harbour Commissioners for pilotage purposes under part 1 of the pilotage Act 1987 so as to include an area outside their harbour in respect of which the Commissioners consider that pilotage should be compulsory.

The applicants for this Order are the Londonderry Port and Harbour Commissioners.

The extended limits of jurisdiction for pilotage purposes are identified by means of a map marked "Londonderry Port and Harbour (Variation of Pilotage Limits) Order (Northern Ireland) 2002" which has been signed and sealed with reference to this Order and deposited at the office of the Department for Regional Development, Clarence Court, 10-18 Adelaide Street, Belfast BT2 8GB. Copies of the map have been deposited at Londonderry Port and Harbour Commissioners offices, Port Road, Lisahally, Londonderry, BT47 1FL, where they are available for inspection at any reasonable hour. The Department for Regional Development has today made a statutory Rule entitled the River Bann Navigation Order (Northern Ireland) 2002. This Order provides new limits of jurisdiction of the Coleraine Harbour Commissioners (Article 3)

This Order also confers the following powers on the Coleraine Harbour Commissioners, as the harbour authority, that is to say:-

- (1) setting out the general powers and duties of the Coleraine Harbour Commissioners in respect of the harbour (Article 4);
- (2) empowering the Commissioners to retain or dispose of land or to manage, use or develop it (Article 5);
- (3) empowering the Commissioners to form wholly-owned subsidiaries for carrying on activities which the Commissioners have power to carry on (Article 6);
- (4) regulating the power of the Commissioners to borrow money (Articles 7 and 8);
- (5) empowering the Commissioners to license pleasure craft and boatmen within the port (Article 9);

The Order further provides for a new Constitution in relation to appointment of the Commissioners and new procedures, etc to be adopted at meetings of the Commissioners (Article 10 and Schedule 1). (2301/34)

The Department for Regional Development has today made a statutory Rule entitled the Airports Byelaws (Designation) Order (Northern Ireland) 2002.

Under Article 18(2) of the Airports (Northern Ireland) Order 1994 the operator of an Airport to which the Article applies may make byelaws for regulating the use and operation of the airport and the conduct of persons while within the airport. Article 18(1) of that Order provides that any airport other than an airport managed by a District Council must be designated for the purposes of Article 18.

This Order designates Belfast International Airport and Belfast City Airport for the purposes of the said Article 18. (2301/35)

## Criminal Justice

### *Proposal for a Draft Criminal Justice (Northern Ireland) Order 2003*

Under the terms of the Northern Ireland Act 2000, the Secretary of State for Northern Ireland has laid before Parliament a Proposal for a Draft Criminal Justice (NI) Order 2003.

The Draft Order proposes a number of important changes to criminal law, all aimed at improving the efficiency and effectiveness of the criminal justice system. They include:

- improving existing bail arrangements to bring certain aspects of Northern Ireland's arrangements into line with those in England and Wales;
- giving the Secretary of State power to make regulations prescribing time limits for the prosecution to complete the preliminary stages of criminal proceedings and during which the accused may be held in custody; and

- a number of changes to Northern Ireland's sexual offence laws to bring them into line with England and Wales and to render them ECHR compliant.

These and the other measures included in the legislation will assist in both modernising and improving the legislative framework and the criminal justice system.
