Whereby and by force of Section 141[1][b] of the Customs & Excise Management Act 1979, the aforesaid three plastic cubes and two extension cables are liable to forfeiture.

If you claim that all or any of the aforesaid goods are not liable to

forfeiture you must within one month from the date of publication of this notice of seizure, give notice of your claim in writing to the Commissioners at an office of Customs and Excise. Your notice must also specify your name and address, the goods claimed as not liable to forfeiture and, if you are outside the United Kingdom, the name and address of a solicitor in the United Kingdom who is authorised to accept service of process and to act on your behalf. Planning (General Development) (Amendment) Order (Northern Ireland) 2003 No. 98

Notice is hereby given that the Department of the Environment, in exercise of the powers conferred by Article 13 of the Planning (Northern Ireland) Order 1991 and of all other powers enabling it in that behalf, made on 25th February 2003, a Statutory Rule entitled the Planning (General Development) (Amendment) Order (Northern Ireland) 2003 No. 98 which will come into operation on 26th March, 2003.

This Statutory Rule amends the Planning (General Development) Order (Northern Ireland) 1993 by the substitution of a new Part 17 to Schedule 1 to that Order. The effect of the substitution of Part 17 Class A is to provide limited permitted development rights for telecommunications code system operators to facilitate minor day-to-day operations. It does not provide permitted development rights for the installation, alteration or replacement of a telecommunications mast or associated apparatus for which planning applications are required.

Part 17 Class B allows for the emergency use of land for up to 6 months to provide replacement moveable apparatus in place of unserviceable apparatus.

Armagh Area Plan 2018 Notice of Intention to Prepare a Planning Development Plan



The Planning Service, an Agency within the Department of the Environment, intends to prepare a development plan under the provision of Part III of the Planning (Northern Ireland) Order 1991 for the area comprising Armagh City and District Council area.

The Plan will be prepared within the context of the Regional Development Strategy. It will inform the general public, statutory authorities, developers and other interested bodies of the policy framework and land use proposals that will be used to guide development and the use of land within the Council area up to the year 2018.

The Plan will focus on a number of issues including: the zoning of land for particular forms of development such as housing, industry and recreation; designations relating to regional policies such as Green Belts; committed public sector proposals and designations of other site specific areas to which local policies will apply, such as local landscape policy areas.

The Department will consult the local council, Government Departments, statutory undertakers, other appropriate bodies and interested parties in the preparation of the Plan.

The Department wishes to ensure that members of the public have the opportunity to participate at this initial key stage in the Plan making process by contributing to the formulation of the key issues which the Plan should consider.

 - 30(9) (review of orders by a Practice Committee);
 - 32 (procedure for investigation of allegations by Health Committee and Conduct and Competence Committee);
 - 33(4) and (7)(a) (application for restoration to the register);
 - 34(4) (functions of legal assessors);
 - 35(3) (functions of medical assessors);
 - 36(3) (functions of registrant assessors);
 - 37(1), (4) and (5) (registration appeals); and

for that purpose, Schedule 3 and article 2 in so far as it relates to it.

- (3) For the purpose of the making of an order by the Privy Council with regard to the functions of legal assessors, article 40(1) (order in respect of legal assessors).
- (4) For the purpose of establishing standards of proficiency and prescribing requirements under article 5(2) and establishing standards and requirements under articles 15(1) and 19(4) and (6), article 14 (advice by the Education and Training Committee).
- (5) For the purpose of establishing standards and requirements under article 15(1), paragraph (3) of that article (consultation).
- (6) For the purpose of establishing standards and arrangements under article 21(1) and giving guidance under article 21(1) or (2), paragraph (3) of that article (consultation).

(a) the following new sub-clause 2(c) were inserted as follows:

(c) in the following modes:

- (i) unattended operation of a CB station;
- (ii) operation of a CB station in digi-peater mode or node operation;
- (iii) operation of all mailbox and bulletin board systems;
- (iv) interconnection with the Public Switch Telephone Network (PSTN)

(b) a new Clause 12 were inserted as follows:

"Operation by the Licensee of data on a CB station"

12. Operation by the Licensee of data on a CB station is limited to a one-to-one operation, which does not include digi-peater mode and shall be on the following basis:

- (a) the channels shall be used in simplex mode only;
- (b) the data unit interface with the Wireless Telegraphy apparatus forming a CB station shall be made only through the external microphone input socket and/or receive audio/speaker output socket with the aid of suitable cables/switch;
- (c) the data modulating the transmitter shall be the AX25 Amateur Packet Radio Link Layer Protocol;
- (d) the class of emission shall be G2D. Only two tones shall modulate the (said) transmitter. The maximum frequency of the highest tone modulating the (said) transmitter shall be 2200 Hz. There shall be not more than 1000 Hz frequency between the two tones. If a connection is not established within 20 seconds, the transmitter keying control line shall be reset;
- (e) the Licensee shall transmit their full postcode in Morse telegraphy:
 - (i) at the beginning and end of each period of communication;
 - (ii) at the end of each interval of 15 minutes, when the period of communication is longer than 15 minutes;
 - (iii) at the beginning of transmission on a new frequency (whenever the frequency of transmission is changed); and
 - (iv) on the same carrier frequency that is being used for communication.
- (f) the Licensee shall ensure that the data interface equipment is compatible with the wireless telegraphy apparatus forming part of a CB Station, that any interconnecting cables/switch which are fitted are suitable for operation and that no interference to other electrical, electronic or radio apparatus is caused;
- (g) the wireless telegraphy apparatus forming part of a CB Station shall comply with UK Interface Requirement 2027 published by the Radiocommunications Agency of the Department of Trade and Industry, when operated in conjunction with the data interface equipment;
- (h) apart from the operation of data on a CB Station, and subject to the preceding clauses, Licensees shall comply with the relevant existing licensing terms provisions and limitations.";

(c) clause 12 were re-numbered clause 13; and

(d) the notes to the Booklet were amended as follows:

- (i) paragraph 4(a)(lii) were replaced with the following words: "Devices designed to encrypt or distort speech or data";
- (ii) a new Note 10 were inserted as follows: "Information which infringes the Data Protection Act 1998, copyright, personal or corporate privacy shall not be sent.", and
- (iii) a new Note 11 were inserted as follows: "Channels EU24(27.235MHz), EU25(27.245MHz) and EU32 (27.325MHz) within the existing CEPT allocations should be used for transmission of data.".
- (iv) a new note 12 were inserted as follows: "Digi-peater mode is mode available within the AX25 Amateur Packet Radio Link Layer Protocol whereby the data unit re-transmits a received packet in the form received and without error correction."
- (v) a new note 13 were inserted as follows:

A node is a data unit connected to one or more CB radios forming all or part of a CB station able to store and re-transmit for onward routing, complete or parts of a message.

NOTICE OF APPLICATION UNDER SECTION 47 OF THE COMPETITION ACT 1998

CASE NO. 1012/2/3/03.

Pursuant to Rule 13 of the Competition Commission Appeal Tribunal Rules 2000 ("the Rules"), the Registrar of the Appeal Tribunals gives notice of the receipt of an application, dated 19th February 2003, under section 47 of the Competition Act 1998 ("the Act") by Aquavita (UK) Limited ("the applicant") of 33 St James's Square, London, SW1Y 4JS, in respect of a decision made by the Director General of Water Services ("the Director") and notified to the applicant on 20th December 2002, ("the Contested Decision").

According to the application the applicant is a company registered in the United Kingdom seeking to establish itself as a water retailer in the United Kingdom.

The Contested Decision rejected the applicant's request to the Director to withdraw or vary his decision notified to the applicant on 4th September 2002 ("the Relevant Decision"). According to the applicant the Relevant Decision found that Northumbrian Water, Severn Trent Water, Thames Water, United Utilities and Yorkshire Water ("the water companies") had not infringed the Chapter II prohibition of the Act by refusing to supply the applicant with water at wholesale prices and that the Director was entitled to close his file on the applicant's complaint that the water companies have abused their dominant positions in the market for the wholesale supply of water.

The applicant seeks the following relief:

1. that the Contested Decision be set aside;
2. a declaration that where an incumbent water company refuses to make available to a water retailer a wholesale supply of water at a reasonable wholesale price (i.e. the ordinary tariff, less a reasonable discount for retail services), that incumbent water company thereby infringes the Chapter II prohibition (section 18 of the Act);
3. in the alternative to the relief sought at point 2 above, that the matter be remitted to the Director for proper consideration and investigation;
4. that interim directions be ordered against the Director, being (in summary) that the Director make disclosure of specified classes of document;
5. that each party should bear its own costs of the appeal.

In summary the principal grounds on which the applicant relies are that the Director:

1. has made a decision within the meaning of section 47 of the Act, namely a decision that there is no infringement of the Chapter II prohibition where an incumbent water company refused to sell water to a water retailer on a wholesale basis for a reasonable wholesale price; and in so deciding the Director has misdirected himself as to the application of the Chapter II prohibition in this case and, hence, erred in law;
2. has wrongly decided not to withdraw or vary that relevant decision under section 47 of the Act; and in so deciding he misdirected himself and erred in law.

Any person who considers that he has sufficient interest in the outcome of the proceedings may make a request for permission to intervene in the proceedings, in accordance with Rule 14 of the Rules.
