**THE ENERGY (NORTHERN IRELAND) ORDER 2003**  
(S.I. No. 2003/419 (N.I.6))

Notice is hereby given that in exercise of the power conferred on Her by paragraph 1(1) of the Schedule to the Northern Ireland Act 2000 (c.1), Her Majesty has made the Energy (Northern Ireland) Order 2003. The Energy Order addresses priority energy issues in Northern Ireland. It strengthens the current energy regulatory and consumer representation arrangements by creating a new Northern Ireland Authority for Energy Regulation and a new energy group within the General Consumer Council for Northern Ireland. Both the Authority and the Council are given enhanced functions and powers to enable them to fulfil their new roles. The Order facilitates the extension of the existing gas transmission

network by enabling gas conveyance charges to be equalised through a process called "postalisation". It makes important changes to the existing electricity and gas licensing arrangements. The Order also enables the imposition of a "renewable obligation" on Northern Ireland electricity suppliers to require them to supply a specified proportion of their electricity from renewable sources.

ELIZABETH THE SECOND by the Grace of God of the United Kingdom of Great Britain and Northern Ireland and of Our other Realms and Territories Queen Head of the Commonwealth Defender of the Faith To Our trusty well beloved the members of the Scottish Parliament.

FORASMUCH as a Bill has been passed by the Scottish Parliament and has been submitted to Us for Our Royal Assent by the Presiding Officer of the Scottish Parliament in accordance with the Scotland Act 1998 the short Title of which Bill is set forth in the Schedule hereto but that Bill by virtue of the Scotland Act 1998 does not become an Act of the Scottish Parliament nor have effect in the Law without Our Royal Assent signified by Letters Patent under Our Scottish Seal (that is Our Seal appointed by the Treaty of Union to be kept and used in Scotland in place of the Great Seal of Scotland) signed with Our own hand and recorded in the Register of the Great Seal We have therefore caused these Our Letters Patent to be made and have signed them and by them do give Our Royal Assent to that Bill *Commanding Also* the Keeper of Our Scottish Seal to seal these Our Letters with that Seal.

This Order should be read in conjunction with Environment (Northern Ireland) Order (2002 Order) (Commencement No. 1) Order (Northern Ireland) 2003 (SR 49 (C.3)) which brought provisions into operation relating to the arrangements for the declaration of Areas of Special Scientific Interest, the notification of owners and occupiers, and related matters concerned with their protection and management.

This Order brings Part III of Schedule 5 (together with so much of Article 53(1) as relates thereto) and Part II of Schedule 6 (together with so much of Article 53(2) as relates thereto) of the Environment (Northern Ireland) Order 2002 into operation on 28th February 2003. The provisions brought into operation provide for the consequential and minor amendments in part III of Schedule 5 to have effect and for the statutory provisions in Part II of Schedule 6 to be repealed.

The Department for Regional Development and Department of Agriculture and Rural Development, being Departments designated for the purposes of section 2(2) of the European Communities Act 1972 have made a Statutory Rule entitled the Harbour Works (Environmental Impact Assessment) Regulations (Northern Ireland) 2003.

The Regulations implement, for Northern Ireland, Council Directive 85/337/EEC (as amended by Council Directive 97/11/EC) in the assessment of the effects of certain public and private projects on the environment, in respect to certain harbour works.

The Regulations come into operation on 14th April 2003. Except for applications relating to harbour works prior to 14th April 2003, these Regulations replace the Harbour Works (Assessment of Environmental Effects) (Northern Ireland) Regulations 1990 and amendments to them made by the Harbour Works (Assessment of Environmental Effects) (Amendment) Regulations (Northern Ireland) 1996.

The main changes made by Directive 97/11/EC, which the Regulations implement are increased coverage of the types of development requiring environmental impact assessment (EIA); a requirement for individual determinations; clarification of the way in which or whether EIA is required for every Annex II project exceeding the thresholds established by the Member States, a requirement to give advice on the content of the environmental statement if the developer so requests; a requirement to publicise the decision on the need for EIA and also the consent decision; a requirement to give reasons for decisions for granting or refusing consent; enhanced consultation arrangements with other Member States where projects are likely to have significant transboundary effects.
