CIVIL AUTHORITIES (SPECIAL POWERS) ACTS (NORTHERN IRELAND), 1922 and 1933.

WHEREAS certain Regulations for Peace and Order in Northern Ireland are contained in the Schedule to the Civil Authorities (Special Powers) Act (Northern Ireland), 1922, and it is provided by sub-section (3) of Section 1 of the said Act that the Minister of Home Affairs shall have power to make Regulations (a) for making further provision for the preservation of the Peace and Maintenance of Order, and (b) for varying or revoking any provision of the Regulations, whether contained in the said Schedule, or made as aforesaid, and that any Regulations made as aforesaid shall, subject to the provisions of the said Act, have effect and be enforced in like manner as Regulations contained in the said Schedule:

Now, therefore, I, the Right Honourable Sir Richard Dawson Bates, Minister of Home Affairs for Northern Ireland, do make the following Regulation for making further provision for the preservation of the Peace and Maintenance of Order, and the said Regulation shall be enforced and have effect in like manner as Regulations contained in the said Schedule, and the said Regulation now made, and the Regulations contained in the said Schedule shall have effect and be construed as if the said Regulation now made formed part of said Regulations in said Schedule, that is to say:—

24c.—Any person who has in his possession, or displays, causes to be displayed, or assists in displaying or in causing to be displayed in any lic place, or permits to be displayed lands and premises occupation or under his control, any emblem, flag or other symbol consisting of three vertical or horizontal stripes coloured respectively green, white and yellow, purporting to be an emblem, flag or symbol representing the Irish Republican Army, or purporting to be an emblem, flag or symbol of an Irish Republic, or purporting to be an emblem, flag or symbol of any organisation declared to be an unlawful association, shall be guilty of an offence against this regulation, and any police constable may seize any such emblem, flag or other symbol so possessed or displayed contrary to this regulation.

PUBLIC HEALTH (IMPORTED FOOD) REGULATIONS, 1925.

PUBLIC HEALTH (IMPORTED FOOD)

AMENDMENT REGULATIONS

(NORTHERN IRELAND), 1933.

The Ministry of Home Affairs for Northern Ireland hereby gives notice, in pursuance of the above-mentioned Regulations, that the Ministry hereby recognises for the purposes of items (a) and (c) or (b) of the Second Schedule to the Amendment Regulations, i.e.,

- (a) A severed part of the carcase of an animal (including the head or any part thereof, and the whole carcase without the head, but not including any part of the carcase of a pig which has been salted, cured, pickled, dried or smoked or otherwise prepared in the manner in which bacon or ham is ordinarily prepared), from which no submaxillary, pre-scapular, pre-crural, superficial inguinal, supramammary or popliteal gland has been taken out;
- (b) Lard, dripping, edible tallow, and all other rendered animal fats, except oleo oil, oleo stearine and premier jus;
- (c) All edible parts of an animal other than (i) the head or other severed parts of the carcase, (ii) the intestines prepared in the form of sausage casings, and (iii) meat which has before importation been made ready for human consumption in the form of a sausage or other prepared or manufactured article of food,

each of the Official Certificates of which particulars are given in the First and Second Schedules to the Notice published by the Ministry of Health in the "London Gazette" of 1st December, 1933, as evidence that the meat to which it relates has been derived from an animal which was free from disease at the time of slaughter and has been dressed or prepared and packed with all necessary precautions for the prevention of danger to public health.

The recognition applies only if the label is securely affixed to the meat, or to the package containing the meat, and if the label has not in any other circumstances, or on any other occasion, been used as an Official Certificate.
