#### SURVEY.

WHEREAS it is provided by section one of the Administrative Provisions Act (Northern Ireland), 1933, that, as from such day as the Governor of Northern Ireland may by Order in the Privy Council of Northern Ireland appoint, the public service in connection with the Ordnance Survey in Northern Ireland shall be transferred from the Ministry of Agriculture to the Ministry of Finance, and the last-mentioned Ministry shall be the department of the Government of Northern Ireland for the administration of that service:

Now I, James Albert Edward, Duke of Abercorn, Knight of the Most Noble Order of the Garter, Knight of the Most Illustrious Order of Saint Patrick, Governor of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland, do hereby order as follows:—

The fifteenth day of December, 1933, is hereby fixed to be the appointed day for the purposes of section one of the said Act.

CIVIL AUTHORITIES (SPECIAL POWERS) ACT (NORTHERN IRELAND), 1922.

WHEREAS by Section 26 of the Regulations contained in the Schedule to the Civil Authorities (Special Powers) Act (Northern Ireland), 1922, it is provided that the Civil Authority may by notice prohibit the circulation of any newspaper for any specified period and that the person circulating or distributing such newspaper within such specified period shall be guilty of an offence against the Regulations in the said Schedule:

Now, I, the Right Honourable Sir Richard Dawson Bates, Minister of Home Affairs for Northern Ireland, being the Civil Authority under the said Act, do hereby prohibit the circulation of the following newspapers entitled:—

"An Phoblacht" or "The Republic," or "The Loyalist" or "The Republican Press."

"The Irish World and American Industrial Liberator."

"Irish Freedom" or "Saiorse na h'Eireann."

or under any other title or alias whatever in Northern Ireland, from the 1st day of January, 1934, until the 31st day of December, 1934.

TOWNS IMPROVEMENT (IRELAND) ACT, 1854.

APPLICATION of the undersigned Twenty-one and more Local Government Electors within the area of the town of Kilkeel, Rural District of Kilkeel and County of Down.

- 1. The "Town" of Kilkeel is under the jurisdiction of the Kilkeel Rural District Council. The ratable value of Kilkeel, including the townlands of Kilkeel and Magheramurphy, is about £4,932, and the rates paid amount to about £2,722, and the present application is that the provisions of the Towns Improvement (Ireland) Act, 1854, may be carried into execution in the town of Kilkeel and the surrounding district comprising the townlands of Kilkeel and Magheramurphy as shown on the annexed Map.
- 2. Under Section 1 of the Towns Improvement (Ireland) Act, 1854, as modified by Section 2 of the Local Government Act (Northern Ireland), 1923, it is provided that before the provisions of the said Act can be carried into execution in any town such a town should have a population of 1,500 inhabitants or upwards as ascertained to the satisfaction of the Ministry of Home Affairs for Northern Ireland.
- 3. The last Official census was taken in the year 1926, and at that time as by reference to said Census Report will appear the population of the town of Kilkeel amounted to 1,632 persons. Such Census was confined to the town of Kilkeel and did not include the extended area proposed to be taken in as shown by the said Map, the said area comprises approximately 780 acres.
- 4. The population proposed to be included in the town of Kilkeel for the purpose of the Towns Improvement (Ireland) Act, 1854, as appears by the said Census Report is 1,882 persons.
- 5. The town of Kilkeel has of recent years developed as a residential district and attracts many visitors in the Summer months.
- 6. It is believed that in the best interests of Kilkeel the time has now arrived when its affairs should be managed by the inhabitants who have an interest in the property and development of Kilkeel.
- 7. Application is therefore respectfully made to the Ministry of Home Affairs for Northern Ireland by the undersigned, being persons upon the Register of Local Government Electors within the area of the boundaries of the town as hereinafter proposed that the provisions of the Towns Improvement (Ireland) Act, 1854, may be applied and carried into execution in the town of Kilkeel and that the boundaries of such town for the purposes of the said Act shall be as follows, that is to say:—The Town of Kilkeel shall consist of the area surrounded by a red verge on the Map attached

hereto comprising the Townlands of Kilkeel and Magheramurphy. The Boundary de-lineated on the said Map is as follows:— Commencing at the intersection of High Water Mark with the Townland Boundary between Derryoge and Magheramurphy marked "A", thence along the same Townland Boundary in a North-Westerly direction to a point marked "B" and continuing along the Townland Boundary between Dunnaman and Magheramurphy from the said point marked "B" to the centre of Aughrim River at the Ford marked "C", thence along the Townland Boundary in the centre of Aughrim Pivos between the centre of Aughrim River between the Townlands of Magheramurphy and Drum-cro to a point marked "D", thence in a Northerly direction along the Boundary between the Townlands of Drumcro and Kilkeel to a point marked "E", continuing in an Easterly direction along the Townland Boundary between the Townlands of Kilkeel and Aughnaloopy to a point marked "F", thence in a South-Easterly direction along the centre of stream on Boundary between the Townlands of Kilkeel and Aughnahoory to a point in the centre of Kilkeel River marked "G", and continuing North-East along the Boundary between the Townlands of Aughnahoory and Kilkeel to a point marked "H". From thence in a Southerly direction along the Townland Boundary between the Townlands of Kil-keel and Maghereagh to intersection with High Water Mark at point marked "J", thence continuing in a South-Westerly direction along High Water Mark to its commencement at the point marked "A".
