ELIZABETH THE SECOND by the Grace of God of the United Kingdom of Great Britain and Northern Ireland and of Our other Realms and Territories Queen Head of the Commonwealth Defender of the Faith To Our trusty and well beloved the members of the Scottish Parliament GREETING:

FORASMUCH as a Bill has been passed by the Scottish Parliament and has been submitted to Us for Our Royal Assent by the Presiding Officer of the Scottish Parliament in accordance with the Scotland Act 1998 the short Title of which Bill is set forth in the Schedule hereto but that Bill by virtue of the Scotland Act 1998 does not become an Act of the Scottish Parliament nor have effect in the Law without Our Royal

Assent signified by Letters Patent under Our Scottish Seal (that is Our Seal appointed by the Treaty of Union to be kept and used in Scotland in place of the Great Seal of Scotland) signed with Our own hand and recorded in the Register of the Great Seal We have therefore caused these Our Letters Patent to be made and have signed them and by them do give Our Royal Assent to that Bill COMMANDING ALSO the Keeper of Our Scottish Seal to seal these Our Letters with that Seal.

## Town & Country Planning Planning (Fees) (Amendment) Regulations (Northern Ireland) 2004 No. 102

These regulations amend the Planning (Fees) Regulations (Northern Ireland) 1995 by increasing the fees payable to the Department of the Environment in respect of applications made under the Planning (Northern Ireland) Order for:

- (a) planning permission for development of land and for the approval of matters reserved in an outline application;
- (b) consent for the display of advertisements; and
- (c) listed building consent.

The Regulations also increase:

- (a) reduced fees, (sometimes referred to as concessionary fees) certain fees for deemed applications and fees for certain statutory authorities;
- (b) fees for applications for certificates of lawful use or development; and
- (c) fees for applications or deemed applications by certain non-profit making organisations.

The general effect of the Regulations will be to increase fees by approximately 10%.

#### THE HEALTH AND PERSONAL SOCIAL SERVICES (NORTHERN IRELAND) ORDER 1972

The regulations provide that the capital limit, above which a resident is not entitled to be assessed as unable to pay for accommodation, is increased to £20,000. The upper and lower limits of a resident's capital for the calculation of tariff income are also increased to £12,250 and £20,000 respectively. The regulations also make changes to capital and income disregards applied in the means test for residential and nursing home care arranged by the Health and Personal Social Services, and provide a new disregard for payments made by the Skipton Fund to people who have been infected with Hepatitis C by NHS blood products. #### **EUROPEAN COMMUNITIES ACT 1972**

The Department of Agriculture and Rural Development has made a Statutory Rule under the European Communities Act 1972 entitled: "Fisheries and Aquaculture Structures (Grants) (Amendment) Regulations (Northern Ireland) 2004".

The Regulations came into operation on 12th March 2004 and amend the Fisheries and Aquaculture Structures (Grants) Regulations (Northern Ireland) 2002 ("the 2002 Regulations") which supplement Community legislation providing for assistance to be paid from the Financial Instrument for Fisheries Guidance in respect of certain categories of investments, projects and actions in the fisheries and aquaculture sector and in the industry sector which processes and markets its products. The Regulations amend the 2002 Regulations by -

- (a) transferring the functions of the Department of Culture, Arts and Leisure under the 2002 Regulations to the Department of Agriculture and Rural Development (regulations 4(e), 8 and 9); and
- (b) updating references to Community legislation in the 2002 Regulations to take account of recent amendments (regulation 4(b) to (d))

The Regulations also add to the types of expenditure which may be eligible for assistance under the 2002 Regulations (regulation 5) and contain consequential amendments (regulations 4(a), (f) and (g), 6 and 7).

This amendment to the Scheme, which comes into force on 1st April 2004 revises certain postage rates, amends the postage rate structure relating to mail sent to members of HM Forces, introduces Airsure packs for European destinations and amends the level of compensation for ordinary postal packets.

Royal Mail Group plc(a) by virtue of the powers conferred upon it by section 89 of the Postal Services Act 2000 and all other powers enabling it in this behalf, hereby makes the following amendment to the Scheme:

Commencement, citation and interpretation

1. (1) This amendment to the Scheme shall come into operation force on 1st April 2004 and may be cited as the Royal Mail Group plc Company Overseas Letter Post Amendment (No. 9) Scheme 2004.

This amendment to the Scheme shall be read as one with the Successor Postal Services Company Overseas Letter Post Scheme 2001(b) (hereinafter called 'the Scheme'), as amended by the Consignia plc Overseas Letter Post Amendment (No. 1) Scheme 2001(c), the Consignia plc Overseas Letter Post Amendment (No. 2) Scheme 2001(d), the

Consignia plc Overseas Letter Post Amendment (No. 3) Scheme 2001(e), the Consignia plc Overseas Letter Post Amendment (No. 4) Scheme 2002(f), the Consignia plc Overseas Letter Post Amendment (No. 5) Scheme 2002(g) ,the Royal Mail Group plc Overseas Letter Post Amendment (No. 6) Scheme 2003(h), the Royal Mail Group plc Overseas Letter Post Amendment (No. 7) Scheme 2003(i) and the Royal Mail Group plc Overseas Letter Post Amendment (No. 8) Scheme 2004(j).

2. A reference in the Scheme to the Successor Postal Services Company shall be read as a reference to Royal Mail Group plc.

Letters and postcards other than airmail packets

- 3.(1) In sub-paragraph (1) of paragraph 5 of the Scheme, the phrase 'Part 2A' shall be deleted and substituted by 'Part 1'.
- (2) In sub-paragraph (2) of paragraph 5 of the Scheme, the phrase 'Part 2B' shall be deleted and substituted by 'Part 2'.
- (3) In paragraph 5 of the Scheme, the following new sub-paragraph (3) shall be inserted:
- '(3) postage at the rates specified in Part 3 of Schedule 1 to the Scheme shall be charged and paid on all letters and postcards for transmission to destinations outside Europe'

Mail to HM Forces and Royal Navy Ships

- 4. Paragraph 6 of the Scheme shall be deleted and the following substituted:
- '6.-(1) Postage at the rates specified in Part 3 of Schedule 3 shall be charged and paid on all letters, postcards, printed packets and small packets posted in the British postal area, or on board a ship registered in any part of the British postal area while the ship is on the highs seas, for transmission:
- (i) to a person on board a ship of the Royal Navy (whether on the high seas or in any part or place outside the British postal area), or
- (ii) to a member of the armed forces of the United Kingdom or of any other Commonwealth country serving outside the British postal area with the armed forces of the United Kingdom or of any other Commonwealth country, being transmitted through a British Forces Post Office or a civilian postal administration in any Commonwealth or foreign country or a US Army Post Office which has agreed to deliver without surcharge letters and postcards at the said rates.
- (2) Postage at the rates specified in Part 3 of Schedule 3 shall be charged and paid on all letters, postcards, printed packets and small packets posted:
- (i) by a member of the Forces referred to in paragraph 6(1)(ii) serving as therein mentioned, for transmission through a British Forces Post Office at which British postage stamps are issued, to a person in the British postal area;
- (ii) on board a ship of the Royal Navy (whether on the high seas or in any port or place outside the British postal area) for transmission to a person in the British postal area.
- (3) Any postal packets for delivery to a person referred to in subparagraph (1) above are delivered by the Post Office to the Ministry of Defence, who arrange for their onward transmission.
- (4) Any postal packets referred to in sub-paragraph (2) above are handed to the Post Office in the British postal area, for onward transmission within that area, by the Ministry of Defence who arranges for the transmission of such postal packets to the British postal area.'

Posting on Board Ship
