1. As from the date of this Order the rate of interest on advances made under section 1 of the Small Dwellings Acquisition Act, 1899, by the Council

of the Rural District of Armagh, shall, notwithstanding anything contained in the Rates of Interest (Housing No. 2) Order (Northern Ireland), 1932, be five per centum per annum:

Provided that nothing in this Order shall affect the rate of interest on any advances made, or to be made, in respect of contracts entered into or applications granted under the said section prior to the date of this Order.

- 2. Save as respects advances made or expenses incurred in respect of contracts entered into or applications granted under the said sections before the said date, the Rural District of Armagh (Rate of Interest) Order, 1927, is hereby revoked.
- 3. This Order may be cited as the Rural District of Armagh (Rate of Interest) Order, 1934.
