The Department of Agriculture and Rural Development (DARD), in accordance with the terms of the above legislation, hereby authorises the:

MOVEMENT OF ALL CLASSES OF LIVESTOCK (CATTLE, GOATS, PIGS AND SHEEP) WITHIN NORTHERN IRELAND

Subject to the following conditions:

GENERAL

1. Prior to any movement the owner/keeper shall inspect the livestock to be moved for signs of disease. If any evidence of disease is found it must be notified without delay to the local Divisional Veterinary Office (DVO). Where any evidence of disease is found, no animal kept on the premises may be moved under this licence.
2. There is a continued need for compliance with all other applicable legal requirements in relation to any movement. All movements are subject to the provisions of:

The Aujeszky's Disease Order (Northern Ireland) 1994

The Cattle Identification (Enforcement) Regulations (Northern Ireland) 1998

The Cattle Identification (Notification of Births, Movements and Deaths) Regulations (Northern Ireland) 1999

The Northern Ireland Authority for Energy Regulation (hereafter referred to as 'the Authority') pursuant to Article 8 (4) of the Gas (Northern Ireland) Order 1996 hereby gives notice as follows:

1. The Authority proposes to grant the following licences to Bord Gais Eireann hereafter referred to as BGE:
 - a) A licence for the conveyance of gas in areas along the route of the North West and South North gas transmission pipelines.
 - b) A licence for the supply of gas in areas along the route of the North West and South North gas transmission pipelines.
2. The Authority considers that BGE has the necessary financial standing and technical expertise to construct natural gas distribution

Cleansing and disinfection

3. Any vehicle used for the movement of livestock under this licence must be thoroughly cleansed and disinfected in accordance with the requirements set out in the Transport of Animals and Poultry (Cleansing and Disinfection) Order (Northern Ireland) 2000.

Types of movement permitted

4. Subject to paragraph 5 below, any animal may be moved under this licence except that the licence may not be used to move animals from:
 - A market of any description to another market of any description.
 - A market of any description to a collecting centre
 - A collecting centre to a market of any description
 - A collecting centre to a collecting centre
 - A trading premises to a market of any description, a collecting centre, another trading premises or any place used for the sale or trading of animals
 - A slaughterhouse to any other place

Disease restriction notice

5. An animal may not be moved from a holding if to do so is in breach of a disease restriction notice served on that holding.

Vehicles

6. Any vehicle used to transport livestock must be purpose built, easily cleaned, leak proof, and covered. The vehicle must be clean and disinfected before transport and must be cleaned and disinfected at the destination holding, DARD approved collection centre or slaughterhouse with a disinfectant approved by DARD after unloading.

Records

7. The owner or keeper, collecting centre operator and haulier must maintain a record of all movements of livestock and the record must be available for inspection at all times.

Documentation

8. MC2 movement notification documentation (cattle), MS movement notification documentation (sheep) or AD movement notification documentation (pigs) must be completed with regard to the animals moved, and forwarded to the Divisional Veterinary Office immediately after the movement has taken place.

MOVEMENTS OFF PREMISES PERMITTED DURING THE STANDSTILL PERIOD

Movement for veterinary treatment, etc.

9. The movement of an animal to a place for veterinary treatment.
10. The movement of an animal from a place for veterinary treatment provided the animal has not come into contact with any other animal while at the place of treatment.
11. The movement of an animal to a laboratory for diagnostic tests to be carried out to ascertain whether the animal is affected by or has been exposed to a disease provided the animal has not come into contact with any other animal while at the laboratory.

Movement for slaughter

12. The movement of livestock from any holding direct to a slaughterhouse.
13. The movement of a pig to a market for pigs intended for immediate slaughter.
14. The movement of livestock to a collecting centre for animals intended for immediate slaughter, provided that
 - (a) the collecting centre has not been and will not be used on the same day for a show or exhibition or for the sale or trading of animals otherwise than for immediate slaughter; and
 - (b) any animal moved to the collecting centre is moved from there direct to a slaughterhouse.

Movement to an artificial insemination centre

15. The movement of livestock to an artificial insemination centre provided that arrangements are in place that ensure, to the satisfaction of the Department, that animals from different herds or flocks of origin are held separately and do not come into contact with each other.

Movement within a single farm enterprise

16. The movement of an animal between premises in a single farm enterprise.

Animals for export

17. For the purpose of direct export for immediate slaughter only the movement of:
 - an animal to another EU Member State (excluding cattle) from a holding of origin or an assembly centre approved under regulation 12(2) of the Animals and Animal Products (Import and Export) Regulations (NI) 2004; or
 - an animal to Great Britain from a holding of origin.

Movement of an animal for breeding

18. The movement of an animal intended for breeding if that animal has been kept in a licensed isolation facility for 6 days immediately prior to the movement.

Movement of an animal to a show or exhibition

19. The movement of an animal to a show or exhibition provided that –
 - (a) it is kept in a licensed isolation facility for 6 days, prior to the movement taking place; or
 - (b) it has been returned to its premises of origin from a show or exhibition and kept in a licensed isolation facility from the time of arriving from the first show or exhibition to the time of leaving for the second show or exhibition.

Imported Animals

20. The movement of an animal from its point of entry into Northern Ireland to its premises of destination.

Vehicles dropping off other animals

21. The movement of an animal, which is on a vehicle that enters premises to drop off other animals, provided it has not left the means of transport while on the premises.

MOVEMENTS ON TO PREMISES THAT DO NOT TRIGGER THE STANDSTILL PERIOD

Arrival at a premises approved under the Sales, Markets and Lairs Order (Northern Ireland) 1975

22. The movement of livestock on to any premises approved under the Sales, Markets and Lairs Order (Northern Ireland) 1975 if the movement is for the purposes of a sale that has been approved under that Order.

Arrival at an artificial insemination centre

23. The movement of an animal on to an artificial insemination centre provided that arrangements are in place that ensure, to the satisfaction of the Department, that animals from different herds or flocks of origin are held separately and do not come into contact with each other

Movement of a pig for breeding purposes

24. The arrival of a pig for breeding on breeding premises provided that
 - (a) it has been kept in a licensed isolation facility for 6 days prior to the movement taking place;
 - (b) it is kept in a licensed isolation facility while on the breeding premises (or for 6 days, whichever is shorter);
 - (c) any pig placed in the said licensed isolation facility with a pig brought on to the premises for breeding purposes has been on the breeding premises for at least 6 days before being placed in that facility; and
 - (d) any other pig moved into the said licensed isolation facility on the breeding premises with the one brought on to those premises remains in isolation for 6 days after the arrival of the pig being brought into the premises, or for 6 days after being moved into the facility with it, whichever is the later.
25. The movement of a pig which is being returned to a holding from a place to which it had been moved for breeding, provided that it is isolated in a licensed isolation facility for 6 days from any other animal immediately after the date of its return.

Return of a bovine animal, goat, pig or sheep from a show or exhibition

26. The return of a bovine animal, goat, pig, or sheep from a show or exhibition to a holding from which it was consigned to that show or exhibition provided that the animal is kept in a licensed isolation facility for 6 days immediately after its return.

Arrival of a male animal for breeding

27. The arrival of a male animal for breeding purposes provided it is kept in a licensed isolation facility for 6 days immediately after its arrival at the premises.

Artificial insemination centre

28. The arrival of a bovine animal that is being returned to a holding from an artificial insemination centre provided it is isolated from

all other animals in a licensed isolation facility for 6 days after its return.

29. The arrival of a pig which is being returned to holding from an artificial insemination centre provided it is isolated from all other animals in a licensed isolation facility for 6 days after its return.
30. The arrival of a sheep or goat that is being returned to a holding from an artificial insemination centre provided that –
 - (a) it is isolated from any other animal for 6 days after its return; and
 - (b) it was isolated from any other animal while at the artificial insemination centre.

Imported animals

31. The arrival of an imported animal at its point of entry into Northern Ireland.

Movement within a single farm enterprise

32. The movement of an animal between premises in a single farm enterprise.

Vehicles collecting other animals

33. The movement of an animal brought on to a holding in a vehicle to collect other animals provided that the animal is not unloaded at that holding.

Arrival from veterinary treatment, etc.

34. The arrival of a bovine animal, goat, pig or sheep being returned to a holding from a place for veterinary treatment or of any offspring to which it has given birth while there provided that it, and any offspring to which it has given birth, have not come into contact with any other animal and in the case of a pig, it and any offspring to which it has given birth, is/are isolated from any other animal for 6 days following its/their return.

This licence is effective from 1 February 2005. It shall remain valid until further notice or unless revoked by the Department.

Failure to comply with the conditions of this licence constitutes an offence under the Diseases of Animals (Northern Ireland) Order 1981 (as amended).
