BY THE GOVERNOR OF NORTHERN IRELAND.

ABERCORN.

WHEREAS it is enacted by Section 6 of the Petty Sessions Clerk (Ireland) Act, 1858, that it shall be lawful for the Lord Lieutenant to order and declare that from a certain time therein to be named two or more districts shall be served by one and the same person as Clerk:

And Whereas by the Government of Ireland Act, 1920, the Orders made thereunder and the Irish Free State (Consequential Provisions) Act, 1922, the powers of the Lord Lieutenant in this respect became vested in and are now exercisable by the Governor of Northern Ireland:

And Whereas by the Petty Sessions Fees and Administration Act (Northern Ireland), 1923, it is provided that the power of the Governor of Northern Ireland to make an Order declaring that two or more Petty Sessions Districts shall be served by one and the same person as Clerk shall be exercisable in respect of any districts whether they are all situate in the same county or not, and it is thereby further provided that the appointment of a person to be the Clerk of such two or more Districts shall, on the first occasion for such appointment, in pursuance of the Order, be made by the Governor of Northern Ireland, who shall select for appointment some one of the persons who filled the office of Petty Sessions Clerk in any of those districts immediately before the coming into force of the Order, or, in the case of the unfitness of all such persons, then some other proper and fit person, and that the salary to be paid to the Clerk so appointed on the first occasion aforesaid for two or more districts shall notwithstanding anything in Section 6 of the Petty Sessions Clerk (Ireland) Act, 1858, be such as the Governor of Northern Ireland in his discretion may fix:

Now, I, James Albert Edward, Duke of Abercorn, K.G., K.P., Governor of Northern Ireland, in pursuance of the powers conferred upon me by the above-mentioned Acts and all other powers me thereunto enabling, do hereby Order and Declare that the Petty Sessions Districts of Aughnacloy and Dungannon, in the County of Tyrone, shall from the 14th day of April, 1934, be served by one and the same person as Clerk:

And I do further appoint Thomas Babbington Gillis, at present Clerk of the Petty Sessions for the District of Dungannon, to be Clerk of the Districts of Aughnacloy and Dungannon:

And I do further direct that the Clerk of Petty Sessions of the Districts of Aughnacloy and Dungannon shall reside within a distance of one and a half miles of the place in which the Court House for the Petty Sessions District of Dungannon is situate:

And I do further fix the salary of the said Thomas Babbington Gillis as Clerk of the aforesaid Districts of Aughnacloy and Dungannon at the annual sum of One Hundred and Ninety-eight Pounds.

The Secretary of State for the Home Department, having consulted the President of the Board of Trade, the Minister of Agriculture and Fisheries and the Secretary of State for Scotland, hereby certifies for the purposes of section twenty-eight of the Agricultural Marketing Act, 1933, that it is expedient that the regulations made on the 19th day of March, 1934, by the Ministry of Agriculture in Northern Ireland in pursuance of Section 14 (1) of the Agricultural Marketing Act (Northern Ireland), 1933, (S.R.O., Northern Ireland, 27) for regulating the removal of pigs from Northern Ireland into Great Britain should have full effect as subserving the purposes of the Pigs Marketing Scheme, 1933, and of the Bacon Marketing Scheme, 1933.

STATUTORY RULES AND ORDERS OF NORTHERN IRELAND 1934. No. 27.

AGRICULTURAL MARKETING. PIGS.

THE AGRICULTURAL MARKETING (REMOVAL OF PIGS) REGULATIONS (NORTHERN IRELAND), 1934, MADE BY THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND UNDER PARAGRAPH (b) OF SUBSECTION (1) OF SECTION FOURTEEN OF THE AGRICULTURAL MARKETING ACT (NORTHERN IRELAND), 1933 (23 and 24 Geo. 5, Ch. 22).

WHEREAS by Sub-section (1) of Section Fourteen of the Agricultural Marketing Act (Northern Ireland), 1933 (hereinafter referred to as "the Act"), it is provided inter alia, that the Ministry of Agriculture for Northern Ireland (hereinafter referred to as "the Ministry") may by regulations make such provision as appears to the said Ministry to be necessary for regulating the removal from Northern Ireland to Great Britain of any agricultural product the mar-keting of which is regulated by a scheme for the time being in force under the Act or under the Agricultural Marketing Act, 1931, the quantity of the product or of any description thereof which may be so removed, and the descriptions of the product which may be so removed, and in particular (without prejudice to the generality of the foregoing provision) for the following matters:

(i) the registration of persons carrying on business in Northern Ireland as dealers in the regulated product; (ii) the exemption from registration of such classes of persons carrying on business as aforesaid as the regulations may specify;

And whereas pigs are an agricultural product the marketing of which is regulated by the Pigs Marketing Scheme (Northern Ireland), 1933, being a scheme for the time being in force under the Act:

Now, therefore, the Ministry, in exercise of the powers conferred upon it by the said Sub-section and of every other power enabling it in that behalf, hereby makes the following regulations, that is to say:—

- It shall not be lawful for any person to remove any pigs from Northern Ireland to Great Britain unless he—
 - (a) is a person who under the Marketing of Pigs (Registration of Dealers) Regulations (Northern Ireland), 1934, is authorised to remove pigs from Northern Ireland to Great Britain; and
 - (b) (i) holds a certificate (in these Regulations called a "quota certificate") issued by the Ministry certifying that the bacon produced from pigs in respect of which the certificate is issued will be included in any quota relating to the quantity of bacon made from pigs produced in Northern Ireland which may be sold; or
 - (ii) holds a permit (in these Regulations called a "pig export permit") issued by the Ministry authorising the export of the number of pigs stated in the permit.
- 2. Quota certificates and pig export permits shall not be issued except—
 - (a) to such persons, and
 - (b) in respect of such descriptions of pigs as the Ministry may from time to time determine, and the number of such certificates and permits shall be such as the Ministry may from time to time determine.
- 3. These Regulations shall come into operation on the date on which a certificate with respect thereto is given by a Secretary of State under Section 28 of the Agricultural Marketing Act, 1933, passed by the Parliament of the United Kingdom.
- These Regulations may be cited as the Agricultural Marketing (Removal of Pigs) Regulations (Northern Ireland), 1934.
