ROAD SAFETY DIVISION

The Department of the Environment on the day of 26th May 2005 approved, under Article 23(4) and (5) of the Road Traffic Offenders (Northern Ireland) Order 1996, the speeding offences detector device mentioned below for the purposes of detection of offences specified in Article 23(2)(a) and (d) of the Road Traffic Offenders (Northern Ireland) Order 1996. The approval has effect as from and including 30th June 2005.

The device known as the Speed Violation Detection Deterrent, manufactured by Symonds Group Ltd, is designed or adapted for recording a measurement of the speed of motor vehicles by means of unattended cameras capturing images of a vehicle at each of two pre determined positions on the road and by recording the time at each position and calculating the average speed over that distance.

The Urban Clearways (Amendment) Order (Northern Ireland) 2005

(b) during the morning peak traffic period on the east side of Boucher Road and on the north side of Crumlin Road (between Carlisle Circus and Oldpark Road); and

(c) during the evening peak traffic period on the west side of Boucher Road and on the south side of Crumlin Road (between Carlisle Circus and Agnes Street).

2. removing the prohibition of waiting by vehicles from Monday to Friday inclusive—

(d) during the morning and evening peak traffic period on both sides of the carriageways of Donegall Street, Grand Parade, Ladas Drive and Mountpottinger Road, Belfast;

(e) during the morning peak traffic period on the south side of College Park (between University Avenue and Botanic Avenue), on the north-east side of Oldpark Road (between its southern junction with Torrens Avenue and Crumlin Road) and on the south side of University Avenue (between Rugby Road and College Park), Belfast; and

(f) during the evening peak traffic period on the north side of College Park (between Botanic Avenue and University Avenue), on the south west side of Oldpark Road (between its southern junction with Torrens Avenue and Crumlin Road) and on the north side of University Avenue (between College Park and Rugby Road).

3. reducing the extent of the prohibition of waiting by vehicles on the north-east and south-west sides of Cliftonville Road, Durham Street (both sides), the north and east sides and south and west sides of Woodvale Road, Belfast;
4. increasing the extent of the prohibition of waiting by vehicles on both sides of Ravenhill Road and Woodstock Road, Belfast and on the west side of Ballygowan Road, Castlereagh.

5. amending the description of the item relating to Ballygowan Road, Castlereagh (east side).

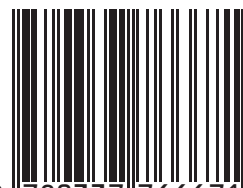
