HEALTH AND SAFETY AT WORK (NORTHERN IRELAND) ORDER 1978

The Chemicals (Hazard Information and Packaging for Supply) (Amendment) Regulations (Northern Ireland) 2005 (S.R. 2005 No. 463)

Notice is hereby given that the Department of Enterprise, Trade and Investment in exercise of the powers conferred on it by the European Communities Act 1972 and the Health and Safety at Work (Northern Ireland) Order 1978, has made Regulations entitled "The Chemicals (Hazard Information and Packaging for Supply) (Amendment) Regulations (Northern Ireland) 2005" (S.R. 2005 No. 463).

The Regulations will amend the current Chemicals (Hazard Information and Packaging for Supply) Regulations (Northern Ireland) 2002 (S.R. 2002 No. 301) ("CHIP 3"), which came into operation on 14 November 2002. They will implement for Northern Ireland, Commission Directive 2004/73/EC of 29 April 2004, adapting to technical progress for the twenty ninth time Council Directive 67/548/EEC on the approximation of the laws, regulations and administrative provisions relating to the classification, packaging and labelling of dangerous substances.

The Regulations bring into operation in Northern Ireland a revised version of the 'Approved Supply List' - a dataset of the hazardous properties of around 5000 chemicals. The revision updates the existing entries for some 450 substances and adds a similar number of new entries. Such updates and additions are undertaken routinely in the light of developing scientific knowledge.

The Regulations will also improve the clarity of CHIP 3 by making a number of minor changes to the text. These are largely editorial and will clarify and correct: they will not alter the existing requirements of CHIP 3.

The Regulations come into operation on 30 November 2005.

Consultation on Proposed Policy on Charging for Drainage Infrastructure Works

The Department of Agriculture and Rural Development (DARD) has published a consultation document on a proposed policy on charging for drainage infrastructure works.

The development of land for housing, commercial or industrial use increases the impermeable surface area and results in increased storm water run-off from the developed area to watercourses. The Rivers Agency spends about £1 million each year on drainage infrastructure improvements to facilitate new development.

In Northern Ireland this cost is borne by the taxpayer, whereas in other parts of the UK provision has been made for the costs to be recouped from the developers. The Government believes that developers in Northern Ireland should also contribute to the cost of drainage infrastructure works necessitated by new developments. It is proposed that these costs will be recouped through a charge on developers.
