Northern Ireland Court Service

Notice is hereby given that the Family Proceedings Rules Committee, in exercise of the powers conferred on it by Article 12 of the Family Law (Northern Ireland) Order 1993, has, with the concurrence of the Lord Chancellor, made the following Rules:-

The Family Proceedings (Amendment No. 2) Rules (Northern Ireland) 2005

These Rules amend the Family Proceedings Rules (Northern Ireland) 1996 (S.R. 1996 No. 322) ("the principal Rules") to make changes linked to Article 12A of the Children Order (Northern Ireland) 1995 ("the 1995 Order") and the Law Reform (Miscellaneous Provisions) (Northern Ireland) Order 2005 ("the 2005 Order").

Article 12A was inserted into the 1995 Order by Article 28 of the Family Homes and Domestic Violence (Northern Ireland) Order 1998 and provides that a court considering whether to make a resident or contact order in favour of a person who is prohibited from molesting another person or who the court considers should be so prohibited shall consider whether the child has suffered or is at risk of suffering harm through seeing or hearing ill-treatment of another person by the prohibited person.

Rules 3, 4 and 5 make an amendment to provide for the service of a new Form C1A as part of an application for an order under Article 8 of the 1995 Order ("an Article 8 order") made under rule 4.5 of the principal Rules. Rule 3 provides that the applicant shall serve the blank copy of Form C1A on each respondent.

Rule 4 provides that the applicant's Form C1A is to be lodged with an application for an Article 8 order if question 6A on Form C1 or question 3A on Form C2 is answered in the affirmative.

Rule 5 provides that a blank Form C1A should be given to the applicant with the copies of the application when the documents are filed with the court, so that it may be served on the respondent(s).

Rule 6 amends rule 4.10(1) of the principal Rules to provide that, in an application for an Article 8 order, the respondent shall file and serve Form C1A in addition to the acknowledgement of application Form C4 if both parts of question 6 or question 7 (or both) on Form C4 are answered in the affirmative.

Rule 7 amends the list of forms in Appendix 1 to the principal Rules to provide for the new Form C1A. It also inserts new Form C1A, substitutes Form C4 and inserts additional questions regarding domestic violence into Forms C1 and C2.

Finally, rule 7 also amends Notes for Guidance to Forms F2 and F3 to take account of a number of amendments made by the 2005 Order.

The amendments shall come into operation on 5th December 2005.

Notice is hereby given that the Family Proceedings Rules Committee, in exercise of the powers conferred on it by Article 12 of the Family Law (Northern Ireland) Order 1993, as extended by section 231 of the Civil Partnership Act 2004 has, with the concurrence of the Lord Chancellor, made the following Rules:-

The Family Proceedings (Civil Partnership: Staying of Proceedings) Rules (Northern Ireland) 2005

These Rules allow for provision to be made in relation to civil partnerships corresponding to the provision made in respect of marriages

by Schedule 1 to the Matrimonial Causes (Northern Ireland) Order 1978. That Schedule makes provision about the relationship between domestic proceedings for divorce, judicial separation, nullity of marriage and declarations as to the validity and subsistence of a marriage of the petitioner, and proceedings in another jurisdiction of a similar type, and provides for when those domestic proceedings shall or may be stayed.

These Rules make similar provision about the relationship between domestic proceedings for an order of dissolution, separation or nullity of civil partnership or for a declaration as to the validity or subsistence of a civil partnership, and proceedings in another jurisdiction of a similar type.

Rule 2 requires any party who is seeking an order in civil partnership proceedings to provide particulars of relevant overseas proceedings in accordance with the provisions of the Family Proceedings Rules (Northern Ireland) 1996.

Rule 3 provides that where there are proceedings for a dissolution order before the court and the trial in those proceedings has not begun then, in certain circumstances, the court shall stay those proceedings if similar proceedings in respect of the said civil partnership are continuing in a related jurisdiction.

Rule 4 provides that where there are proceedings before the court and the trial in those proceedings has not begun then, if the balance of fairness makes it appropriate, the court can stay all or part of those proceedings if there are similar proceedings continuing in another jurisdiction. Rule 5 provides for the discharge of orders staying proceedings under rules 3 and 4.

Rule 7 makes provision about the court's power to make certain ancillary relief orders where a stay is imposed under these Rules by reference to proceedings in a related jurisdiction. Rule 8 makes provision about the effect of orders already made in civil partnership proceedings which have been stayed by reference to proceedings in a related jurisdiction. Rule 6(3) makes clear that these provisions do not affect the court's power to deal with orders which remain in force, enforce orders in relation to any period when they were in force or make orders once proceedings are no longer stayed.

Rule 9 provides that where proceedings are for more than one of the following – an order for dissolution, nullity or separation— but the proceedings are stayed only in so far as they are for some of those orders, rules 7 and 8 do not apply but the court may not make a lump sum order or a relevant order in respect of the proceedings so far as they are stayed.

Rule 10 makes clear that these Rules do not affect any other power which the court might have to stay the proceedings.

WEIGHTS AND MEASURES (NORTHERN IRELAND) ORDER 1981

The Department of Enterprise, Trade and Investment has made a Statutory Rule entitled:

The Measuring Equipment (Liquid Fuel and Lubricants) (Amendment) Regulations (Northern Ireland) 2005 (S.R. 2005 No. 472).

The Regulations amend the Measuring Equipment (Liquid Fuel and Lubricants) (Amendment) Regulations (Northern Ireland) 1998 and apply to equipment used for trade to measure liquid fuel (other than liquefied petroleum gas) in a quantity of 100 litres or less (but do not apply to equipment for automatic measuring of constant nominal quantities).

This technical SR stems from a review of the equivalent GB Regulations, the Measuring Equipment (Liquid Fuel and Lubricants) Regulations 1995². The intention was to ensure that they were still relevant and up to date

The Regulations make the following changes to the 1998 Regulations:

- require that zero readings are not affected by hose dilation;
- require that instruments bear an indication of the product that they deliver;
- remove the requirement for the 20 litre test at minimum flow rate;

- require that a test report be attached if factory testing is carried out;
- remove an outdated provision that related to conversion to metric These Regulations, which come into operation on 5 December 2005, are made under Articles 9(1) and 13(1) of the Weights and Measures (Northern Ireland) Order 1981.
