##### Channel Tunnel (International Arrangements) Order 2005 (S.I. 2005/3207)

The Secretary of State for Transport hereby gives notice that on and after Wednesday 25 January 2006 the Regulation made by the Intergovernmental Commission on the Channel Tunnel (IGC) to transpose three EC rail Directives to the Channel Tunnel has the force of law in the United Kingdom. This notice is made pursuant to Article 3 of the Channel Tunnel (International Arrangements) Order 2005, which provides that the Secretary of State for Transport will give notice of the date.

The Directives transposed by the IGC regulation are:

- Council Directive 91/440/EEC of the Council of 29 July 1991 on the development of the Community's railways, as amended by Directive 2001/12/EC dated 12 February 2001 and Directive 2004/51/EC dated 29 April 2004, both of the European Parliament and of the Council;

- Council Directive 95/18/EC dated 19 June 1995 on the licensing of railway undertakings, as amended by Directive 2001/13/EC dated 26 February 2001 of the European Parliament and of the Council; and
- Directive 2001/14/EC dated 26 February 2001 of the European Parliament and of the Council on the allocation of railway infrastructure capacity and the levying of charges for the use of railway infrastructure and safety certification.

#### *Belvoir Road & Newtownbreda Road, Belfast: Stopping Up*

The Department for Regional Development gives notice that it proposes to make an Order under Article 68 of the Roads (Northern Ireland) Order 1993, the effect of which would be to stop-up the following lengths of roads to road traffic upon the completion of works providing alternative facilities for that traffic:

- The south-eastern side of the south-eastern carriageway of Belvoir Road, Belfast at a line from a point 179.5 metres north-east of its junction with Dunseverick Avenue to a point 211.2 metres north-east of that junction.
- The north-western side of Newtownbreda Road, Belfast, at a line from a point 404.4 metres south-west of its junction with Beechill Road to a point 432.5 metres south-west of that junction.
- Newtownbreda Road, Belfast, at a line from a point on its south-eastern side 384 metres south-west of its junction with Beechill Road to a point on its north-western side 418 metres south-west of that junction.
- Newtownbreda Road, Belfast, at a line from a point on its north-western side 274 metres south-west of its junction with Beechill Road to a point on its south-eastern side 292 metres south-west of that junction.

The roads to be stopped-up are delineated on maps which together with a copy of a draft Order may be inspected by any person free of charge at all reasonable times during the period from 1st February 2006 and 13th March 2006 at the Department's Roads Service offices, Headquarters, Room 201, Clarence Court, 10 – 18 Adelaide Street, Belfast BT2 8GB; and Eastern Division, Hydebank, 4 Hospital Road, Belfast BT8 8JL.

Any person may within the said period object to the proposal by written notice to Roads Service Headquarters at the address above stating the grounds of objection.
