The Belfast Metropolitan Area Plan 2015 is a development plan being prepared under the provisions of Part III of The Planning (Northern Ireland)

Order 1991 by the Planning Service, an Agency within the Department of the Environment. Following publication of the Belfast Metropolitan Area Plan 2015 Draft Plan in November 2004, the Department invited representations over an 8-week period ending on 25 January 2005.
