The Northern Area Plan 2016 is a development plan being prepared under the provisions of Part III of The Planning (Northern Ireland) Order 1991 by the Planning Service, an Agency within the Department of the Environment. Royal Mail Group plc (a) by virtue of the powers conferred upon it by section 89 of the POSTAL SERVICES ACT 2000(b) and of all other powers enabling it in this behalf, hereby makes the following Scheme:

Commencement, citation and interpretation
