A service provision change occurs where services are outsourced, insourced or assigned to a new contractor.

These Regulations apply to Northern Ireland only. They should be read in conjunction with the 2006 Regulations which make provision in respect of Northern Ireland, subject to the modifications contained within Schedule 1 to those Regulations, for the treatment of employees, and related matters on the transfer of an undertaking or business.

These Regulations shall apply to a service provision change that takes place on or after 6 April 2006.
