FORASMUCH as a Bill has been passed by the Scottish Parliament and has been submitted to Us for Our Royal Assent by the Presiding Officer of the Scottish Parliament in accordance with the Scotland Act 1998 the short Title of which Bill is set forth in the Schedule hereto but that Bill by virtue of the Scotland Act 1998 does not become an Act of the Scottish Parliament nor have effect in the Law without Our Royal Assent signified by Letters Patent under Our Scottish Seal (that is Our Seal appointed by the Treaty of Union to be kept and used in Scotland in place of the Great Seal of Scotland) signed with Our own hand and recorded in the Register of the Great Seal We have therefore caused these Our Letters Patent to be made and have signed them and by them do give Our Royal Assent to that Bill COMMANDING ALSO the Keeper of Our Scottish Seal to seal these Our Letters with that Seal.

#### **THE GREENHOUSE GAS EMISSIONS TRADING SCHEME (NORTHERN IRELAND) DIRECTIONS 2006**

The Department of the Environment in exercise of the powers conferred by regulation 42 of the Greenhouse Gas Emissions Trading Scheme Regulations 2005 has issued Directions to the Chief Inspector with respect to his functions under those regulations.

The Directions provide that: -

- the Chief Inspector should refuse any application for a permit, or a variation to an existing permit, before the EU Emissions Trading Scheme (EU ETS) Phase II National Allocation Plan (NAP) is submitted to the Commission, where the application relates to a new installation or extension which will not start operating until Phase II; and
- where a permit has already been varied prior to submission of the Phase II NAP on the basis that the new installation or extension will start in Phase I, the Chief Inspector should use the general power to vary permits to revoke that variation if the new installation or extension will not start operating until Phase II.

The Directions were issued on 19 July 2006 and will come into force on 24 July 2006.

### **Appeal of Decision Made by Monaghan County Council**
