The Planning (Northern Ireland) Order 1991

The Craigavon Town Centre Boundaries and Retail Designations Plan 2010 is a development plan being prepared under Part III of the Planning (NI) Order 1991 by the Planning Service, an Agency within the Department of the Environment. The Plan relates to the town centres of Central Craigavon, Lurgan and Portadown and its purpose is to inform the general public, statutory authorities, developers and other interested bodies of the policy framework that will be used to guide retail and related development decisions within the three town centres.

Following the consideration of representations made in accordance with Article 5 (3) of the Planning (Northern Ireland) Order 1991, the Department prepared the Draft Craigavon Town Centre Boundaries and Retail Designations Plan 2010. The Department for Regional Development has determined in accordance with Article 28 (3) of the Planning (Amendment) (Northern Ireland) Order 2003, that the Draft Plan is in general conformity with the Regional Development Strategy for Northern Ireland 2025.

The Draft Plan was published on 20th December 2005 and made available for public inspection, together with the supporting Strategic Environmental Assessment, Retail Study Report, and Statement of Conformity. The Department by public notice advised that representations could be submitted over an 8 week period ending on 14 February 2006. In early May the Department published a further public notice which indicated that representations were available for public inspection and advised of its intention to hold a public inquiry. This notice also invited representations on the objections over an eight week period ending on 30th June 2006.

Due to a flaw in the notification procedure at the Draft Plan publication stage, the Department has decided to re-advertise the Draft Plan and invite representations over a new eight week period.

The Draft Plan, consisting of a written statement and accompanying maps, and the supporting Strategic Environmental Assessment, Retail Study Report and Statement of General Conformity, will be available for public inspection from the 25th August to 20th October during normal office hours (10am to 4.30pm Monday to Friday excluding public holidays) at the Craigavon Divisional Planning Office.

FLOOD PROTECTION SCHEME

The Department of Agriculture and Rural Development hereby gives notice, in pursuance of Article 12A (3) of the Drainage (Northern Ireland) Order 1973 (as amended) that it proposes to carry out a drainage scheme involving:-

The construction of approximately 670m of floodwalls along the banks of the Ballymully River and adjoining tributary (Coltrim), within the village of Moneymore. The floodwalls will consist of approximately 545m of steel sheet piles and 120m of galvanised steel flood protection barrier. An Environmental Scoping Exercise has been conducted which highlighted issues regarding the timing of the works and identified possible remedial works to mitigate against environmental impacts. Subsequently the nature and timing of relevant aspects of the works will be programmed to avoid the nesting and spawning seasons respectively. Upon completion of the flood defences significant planting along the river corridor and reinstatement of affected areas will be completed, in agreement with riparian owners. It is also proposed as part of the river reinstatement to construct additional fishery enhancement measures along affected stretches of the watercourses.

Having taken account of the characteristics of the works in the proposed scheme, their location and potential impacts, the Department considers the proposed scheme is not likely to have significant environmental effects on the environment and does not intend to prepare an Environmental Statement.
