The Department of Agriculture and Rural Development for Northern Ireland hereby gives Notice in pursuance of Article 12 (as amended) of the Drainage (Northern Ireland) Order 1973 that it proposes to carry out a drainage scheme on the Lisbane Stream, Monkstown, Newtownabbey.

The proposed Scheme relates to a 150m length of the Lisbane Stream which flows in a westerly direction from the junction of Twinburn Road and Monkstown Road to the inlet at Monkstown school.

The Scheme will comprise the replacement of the existing inadequate 300mm diameter culvert with 90m length of 450mm diameter pipes, and regrading of the open channel downstream of the proposed culvert for 60m.
