THE CONTROL OF ASBESTOS REGULATIONS (NORTHERN IRELAND) 2007 (S.R. 2007 No. 31)

Notice is hereby given that the Department of Enterprise, Trade and Investment, in exercise of powers conferred on it by the Health And Safety at Work (Northern Ireland) Order 1978 has made Regulations entitled "The Control of Asbestos Regulations (Northern Ireland) 2007 (S.R. 2007 No. 31)".

The Regulations revoke and replace the Control of Asbestos at Work Regulations (Northern Ireland) 2003, the Asbestos Licensing Regulations (Northern Ireland) 1984 and the Asbestos (Prohibitions) Regulations (Northern Ireland) 1993 with a single set of Regulations. In addition the proposed Regulations will implement, as regards Northern Ireland, Council Directive 2003/18/EC amending Council Directive 83/477/EEC, concerning the protection of workers from the risks related to exposure to asbestos at work.

The Regulations come into operation on 1st March 2007, except for regulation 20(4) which comes into operation on 6th April 2007.

By virtue of Article 18(1) of the Health and DSafety at Work (Northern Ireland) Order 1978, and with the consent of the Department of Enterprise, Trade and Investment, being the Department concerned ("the Department"), the Health and Safety Executive for Northern Ireland ("the Executive") has on 23rd January 2007, approved the undermentioned Codes of Practice approved by the Health and Safety Commission on 25th July 2006.

The management of asbestos in non-domestic premises (L127 ISBN 0-7176-6209-8);

Work with materials containing asbestos (L143 ISBN 0-7176-6206-3;

These Codes of Practice give practical guidance on The Control of Asbestos Regulations (Northern Ireland) 2007 (S.R. 2007 No. 31). They come into operation on 1st March 2007.

Withdrawal of Approval

THE PLANNING TREES (AMENDMENT) REGULATIONS (NORTHERN IRELAND) 2007
