RING ROAD DRAIN, BALLYMONEY DRAINAGE AND INFRASTRUCTURE SCHEME

- (iv) replace the requirement to demonstrate major accident risks are "as low as is reasonably practicable" with a demonstration that such risks are identified and relevant statutory provisions are complied with;
- (v) introduce a new fallback power directing the duty holder to revise a safety case;
- (vi) introduce a statutory right of appeal against regulatory decisions to the Department of Enterprise, Trade and Investment; and
- (vii) provide for general updating throughout and consequential amendments to related Regulations.

In addition, the Regulations make a small amendment to the Offshore Installations (Prevention of Fire and Explosion, and Emergency Response) Regulations (Northern Ireland) 1995 (S.R. 1995 No. 345) (PFEER) to clarify that rescue and recovery arrangements should always include external parties, such as coastguard and helicopter support.

Total sum to be raised

1. The Office of Fair Trading (OFT) hereby gives general notice pursuant to section 234A(4) of the Financial Services and Markets Act 2000 (FSMA) of a determination made by the Financial Ombudsman Service Limited (FOS) with the approval of the Financial Services Authority.

The Determination was made pursuant to section 234A(1) of FSMA and determines that the sum of £2,475,000 is to be raised by way of contributions for the period ending 31 March 2008 for the purpose of funding the establishment of the ombudsman scheme so far as it relates to the consumer credit jurisdiction and its operation in relation to the consumer credit jurisdiction. Such sum includes collection costs of £75,000 but excludes any value added tax.

Contributions

2.
