1934, No. 66.

Determination by the Ministry of Finance under Section 3 of the Intoxicating Liquor Act (Northern Ireland), 1923, as amended by the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925, of the rates at which charges are to be imposed in respect of licences for the sale of intoxicating liquor by retain to be granted or renewed during the year ending 30th September, 1935.

In pursuance of sub-sections (3) (b) and (4) of Section 3 of the Intoxicating Liquor Act (Northern Ireland). 1923, as amended by the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925, the Ministry of Finance hereby determines that the rates at which charges are to be levied in respect of all licences for the sale of intoxicating liquor by retail granted or renewed during the year ending 30th September, 1935, shall be eighty per cent. of the maximum rates of charge authorised by sub-section (1) of Section 1 of the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925.

MILK INDUSTRY ASSISTANCE GRANT.

EQUALISATION PAYMENTS.

The Ministry of Agriculture for Northern Ireland, in exercise of the powers conferred upon it by sub-section (1) of section 9 of the Milk and Milk Products Act (Northern Ireland), 1934, has made regulations governing the making of equalisation payments in respect of milk produced in Northern Ireland and delivered to a creamery and used for the purpose of the extraction of cream for sale as such for manufacture into butter. These regulations, which are entitled "The Milk (Equalisation Payments) Regulations (Northern Ireland), 1934," came into operation on the 16th August, 1934.

MERCHANDISE MARKS ACT, 1926. REFERENCE TO THE STANDING COMMITTEE.
