CIVIL AUTHORITIES (SPECIAL POWERS) ACTS (NORTHERN IRELAND), 1922 and 1933.

Whereas there is reason to believe that assemblies of persons purporting to be members of the Irish Unemployed Workers' Movement have been or are about to be convened on the 11th October, 1934, at or near Frederick Street or elsewhere in the City of Belfast, for the purpose of holding meetings or organising a procession or processions:

And whereas there is reason to apprehend that such assemblies of persons and the holding of such meetings and processions will give rise to grave disorder and conduce to a breach of the peace:

Now, therefore, I, the Right Honourable Sir Richard Dawson Bates, Minister of Home Affairs for Northern Ireland, being the Civil Authority under the said Acts, do hereby prohibit the holding of any such meetings or processions.
