1934 REVIEW OF THE OPERATION OF THE RAILWAY FREIGHT REBATES SCHEME AND

Application in Respect of Administrative Expenses.

Notice is hereby given that the Railway Rates Tribunal will sit at 10-30 a.m. on Monday, the 19th November, 1934, in Court "A," Judges' Quadrangle, Royal Courts of Justice, London, W.C.2, to review the operation of the Railway Freight Rebates Scheme for the year ending 30th September, 1934, pursuant to the provisions of Part 1 of the Eleventh Schedule to the Local Government Act, 1929.
