Now therefore, the Ministry of Home Affairs for Northern Ireland, in exercise of all powers in that behalf enabling the Ministry, by this Order consents and declares that the County Council may, if they see fit, approve of the expenditure on the roads of the Rural District of Lisburn proposed or about to be proposed by the Council of the said Rural District for the local financial year ending on the Thirty-first day of March, 1923, provided always that this consent and declaration shall not extend to the approval by the County Council of any

expenditure proposed or about to be proposed as aforesaid, which is not in accordance with the report and recommendations of the County Surveyor, or which will cause the total expenditure on the roads of the said Rural District in the said local financial year to exceed the sum of Twenty-three Thousand, Five Hundred Pounds.

ORDER.

CIVIL AUTHORITIES (SPECIAL POWERS) ACT (NORTHERN IRE-LAND), 1922.

I, the Right Honourable Sir Richard Dawson Bates, Minister of Home Affairs for Northern Ireland, being the Civil Authority under the Civil Authorities (Special Powers) Act (Northern Ireland), 1922, by virtue of the powers vested in me by the said Act and the Regulations made thereunder, and of all other powers enabling me in this behalf, do hereby order and require that every person within the areas specified in the Schedule hereto, shall remain within doors between the hours of 11-30 o'clock p.m. and 5 o'clock a.m., unless provided with a Permit in writing from the County Inspector of Royal Irish Constabulary of the County in Northern Ireland for which the Permit is required, or from some person duly authorised by such County Inspector, or from the District Inspector of Royal Irish Constabulary of the District in Northern Ireland for which the Permit is required:

Provided that any Permit granted under this Order may be revoked at any time by the person authorised to issue the same, who shall, in every such ease, send notice in writing to the person to whom the Permit was granted of its having been revoked.

This Order shall come into force at 11 o'clock p.m. on the 4th day of November, 1922.

This Order varies the Order made by me on the 25th day of May, 1922, in so far as that Order applied to the areas specified in the Schedule hereto, but not otherwise.

SCHEDULE.

The following areas within Northern Ireland, that is to say:

- 1. All that area outside the boundary of the County of the City of Belfast which is within a radius of twelve statute miles from the Terminus in Belfast of the Great Northern Railway of Ireland, such radius to be measured on the Ordnance Survey Map, scale ½ mile to 1 inch.
- 2. The Urban District of Bangor, in the County of Down.

NOTES.

- 1. The Order of the 25th May, 1922, imposed Curfew from 11 p.m. to 5 a.m. within the area of Northern Ireland, excepting the County of the City of Belfast.
- 2. The existing Curfew hours within the County of the City of Belfast, that is, 11-30 p.m. to 6 a.m., remain in force.
- 3. Under this Order and the Regulations above specified every person who is in the area to which this Order applies during Curfew hours must during those hours either remain in his usual place of abode, or at a hotel or registered lodging-house where he is duly registered. If he intends to stay elsewhere during Curfew hours he must give previous notice to the Police at the Police Station nearest to the house where he intends to stay of his intention to stay therein.
- 4. Inmates of, or persons engaged at schools, hospitals, or other charitable or religious institutions during Curfew hours may remain therein during these hours.
- 5. This Order will not affect persons conveying to a hospital a person requiring treatment thereat.
- 6. Existing Permits, so long as they are in force, hold good for the periods covered by them, and for the Curfew hours named in this Order.
- 7. In each Permit will be stated the area within which it holds good. No Permit will hold good in any area save that for which it is granted unless endorsed to that effect by a person having authority to issue a Permit for such additional area. In each Permit will be stated the hours for which it holds good.
- 8. Applications for Permits should be made by post to the Head-Constable or Sergeant in charge of the Police Barracks of the sub-district in which the applicant resides or in which he is visiting, and should state the purpose for which they are required. The Sergeant will forward them to his District-Inspector without delay.

The Residuary Share of Reserved Taxes is the net sum due to the Northern Government from the produce of taxes collected by the British Treasury and attributable to Northern Ireland after deduction of the Imperial contribution and the cost of Reserved Services.

NOTES.—The Exchequer Account of Northern Ireland is the general account of Receipts and Issues established under the Exchequer and Audit Act, 1921.

The Exchequer Account is a cash account showing the financial position of the Northern Government at a certain date. The amounts shewn under "Revenue" are sums transferred from a subsidiary Revenue Account to the Exchequer after due provision for possible rebates and repayments has been made. Similarly, the amounts shewn under "Expenditure" are the issues made from the Exchequer on account of the Services administered by the various Departments, and, subject to balances in their hands,

Under the Exchequer and Audit Act, 1921, the whole of the Receipts into the Exchequer form one general Consolidated Fund. Standing charges against the revenue of the year under Act of the Northern Parliament are shewn as Consolidated Fund Services. Other charges on revenue are voted by the House of Commons and are shewn as Supply Services.

STATUTORY RULES AND ORDERS OF NORTHERN IRELAND.

1922, No. 60.

Regulations made by the Ministry of Finance, dated 29th September, 1922, relating to the Preparation, Issue and Cancellation of Preparation, Northern Ireland Treasury Bills under the Acts 40 & 41, Vict. c. 2, 52 & 53 Vict. c. 6, Sec. 5, 10 & 11 Geo. 5, c. 67. Secs. 8 & 20 (3).

In exercise of the powers conferred upon it in relation to the Exchequer and Consolidated Fund of Northern Ireland by or in pursuance of section 9 of the Treasury Bills Act, 1877, section 5 of the National Debt Act, 1889, sections 8 and 20 (3) of the Government of Ireland Act, 1920, and certain Orders made by His Majesty in Council under the lastmentioned Act, the Ministry of Finance for Northern Ireland (hereinafter referred to as "The Ministry") makes the following Regu-

I. Whenever it is required to exercise the powers conferred by the Treasury Bills Act, 1877, the Ministry will issue Northern Ireland Treasury Bills (hereinafter referred to as "Bills") in one of the following ways:—

A. The Ministry may issue Bills with a fixed rate of interest to the Exchequer Bank within the meaning of the Exchequer and Audit Act, 1921, or to such other Bank as may be willing to buy the same.

(1) The rate of interest of the Bills so

issued shall be fixed by the Ministry.
(2) The currency of the Bills shall be for any period not exceeding 12 months.

(3) The principal of such Bills shall be repaid at the date mentioned in each Bill.

- B. The Ministry may invite tenders for Bills.
 - (1) Notice that such tenders will be received at the Office of the Exchequer Bank on a given day shall be published in the Belfast Gazette not less than five clear days before the date on which tenders are to be delivered, and shall specify the period (not exceeding 12 months) for which, and the terms and conditions subject to which, the Bills are to be issued.

(2) The principal of such Bills shall be repaid at the date mentioned in each Bill.

(3) The Ministry will from time to time instruct the Exchequer Bank as to the form in which the tenders are to be made, and as to any other necessary proceedings in relation thereto.

(4) The Ministry reserves to itself the right of refusing tenders, if it should think proper so to do.

(5) The tenders shall be opened at the Exchequer Bank in the presence of such person or persons as the Ministry shall from time to time direct.

II. The Permanent Secretary for the time being to the Ministry will sign each Bill, or his name will be engraved thereon, and Bills will be numbered in arithmetical order throughout each financial year, commercing with new numbers in each year.

III. When the Exchequer Bank or any other Bank shall have signified their willingness to buy Bills carrying a fixed rate of interest, or when any tender or tenders for Treasury Bills shall have been accepted by the Ministry, a Warrant of the Ministry of Finance, drawn in the terms of the form A annexed to these Regulations, will be transmitted for the counter-signature of the Comptroller and Auditor-General for Northern Ireland authorising the preparation and issue of such number of Bills and for such amounts as are specified in the Warrant.

IV. Bills shall be prepared by the Ministry in the Form B annexed hereto in such numbers as may be authorised from time to time.

V. The Bills when ready for issue will be transmitted to the Exchequer Bank, and upon receipt by the Bank of the sums therein specified, will be delivered by the Bank to the order of the person or persons entitled thereto. If the Bills are issued to the Exchequer Bank payment shall be made by the Bank to the Ministry.

VI. The amount received for Bills sold will be carried to the account of the Exchequer of Northern Ireland, as provided by the fifth section of the Treasury Bills Act, 1877, in its application to Northern Ireland. When the interest on the money advanced on Bills is paid by allowing discount at the date of issue the Ministry will direct the issue to the Exchequer Bank from the Northern Exchequer of the amount of such discount, and the Bank will thereupon pay to the Exchequer Account a sum equal to the full nominal value of the Bills.

VII. The principal sums of Bills will be payable at the Exchequer Bank, or in the case of Bills issued to that Bank at the Office of the Ministry, on the dates specified in the Bills, without grace, and the discharge for the payment of such Bills shall be an acknowledgment of receipt, to be given on the back of the Bills, or on a schedule of the numbers and amounts of the Bills.

VIII. When Bills have been paid off by the Exchequer Bank they will be cancelled in such manner as may be determined upon by the Bank, and such cancelled Bills will thereafter be returned to the Ministry to be destroyed.

IX. When upon any representation made by any holder of a Bill, the Ministry has reason to believe that a Bill has been lost, destroyed or defaced, the Ministry will cause a Warrant to be prepared authorising the issue of a duplicate of such Bill to the person or persons applying for the same, upon the execution by them of the usual bond of indemnity.
