GRAMMAR SCHOOLS (CHARGES) (AMENDMENT) REGULATIONS (NORTHERN IRELAND) 2008

Notice is hereby given that the Department of Education in exercise of powers conferred on it by Article 132 of the Education Reform (Northern Ireland) Order 1989 which was substituted and Article 132A added by Article 48 of the Education and Libraries (Northern Ireland) Order 1993, has made a statutory rule entitled:

Grammar Schools (Charges) (Amendment) Regulations (Northern Ireland) 2008.

These regulations amend the Grammar Schools (Charges) Regulations (Northern Ireland) 1992 and revoke the Grammar Schools (Charges) (Amendment) Regulations (Northern Ireland) 2006.

The purpose of this rule is to allow Boards of Governors of voluntary grammar schools to charge a fee in respect of pupils enrolled in the secondary department of the school for the purpose of meeting expenditure on the provision or alteration of school premises or on the provision of associated equipment. It also increases the maximum amount which the Board of Governors may charge from £130 to £140 with effect from 1 November 2008. (2301/41)

THE MATERNITY AND PARENTAL LEAVE ETC. AND THE PATERNITY AND ADOPTION LEAVE (AMENDMENT) REGULATIONS (NORTHERN IRELAND) 2008

Notice is hereby given that the Department for Employment and Learning, in exercise of the powers conferred by Articles 70C(2), 105(4), (6) and (7), 107B(4), (7) and (8) and 131(1) of the Employment Rights (Northern Ireland) Order 1996, has made a Statutory Rule entitled The Maternity and Parental Leave etc. and the Paternity and Adoption Leave (Amendment) Regulations (Northern Ireland) 2008.

This Statutory Rule amends the provisions of the Maternity and Parental Leave etc. Regulations (Northern Ireland) 1999 and the Paternity and Adoption Leave Regulations (Northern Ireland) 2002 respectively. The amendments, which will apply to the parents of children expected to be born or placed for adoption on or after 5 October 2008, remove distinctions between the rights to non-pay benefits of employees on ordinary maternity leave and those on additional maternity leave. Similar distinctions between the rights of employees on ordinary adoption leave and additional adoption leave are also removed.

THE PRODUCER RESPONSIBILITY OBLIGATIONS (PACKAGING WASTE) (AMENDMENT No. 2) REGULATIONS (NORTHERN IRELAND) 2008

The Department of the Environment has made a Statutory Rule entitled The Producer Responsibility Obligations (Packaging Waste) (Amendment No. 2) Regulations (Northern Ireland) 2008 (S.R.2008 No. 373). The Rule, which is made under powers conferred by Section 2(2) of the European Communities Act 1972 and Articles 3-5 of the Producer Responsibility Obligations (Northern Ireland) Order 1998, imposes on exporters an obligation to be accredited by the Department before they can issue a packaging waste export recovery note, as

evidence of the export of the tonnage of packaging waste specified in the note for reprocessing outside the United Kingdom. These Regulations revise the requirements for accreditation of an exporter imposed by the 2007 Regulations. The Regulations come into operation on 13 October 2008.
