Neagh Bann International River Basin District

Publication of the draft Plans for a six month consultation is a requirement of the Water Framework Directive and the transposing legislation, The Water Environment (Water Framework Directive) Regulations (Northern Ireland) 2003 (the Regulations), the purpose of which is to establish a strategic planning process to manage, protect and improve the water environment. That process applies to the North Eastern River Basin District and the part of each International River Basin District falling within Northern Ireland.

The draft Plans are also subject to the requirements of the Strategic Environmental Assessment and Habitats Directives and draft environmental reports and appropriate assessments have been prepared and published for consultation over the same period (22 December 2008 – 22 June 2009).
