STATUTORY RULES AND ORDERS OF NORTHERN IRELAND.

AGRICULTURAL MARKETING (PIG INDUSTRY) ACT (NORTHERN IRELAND), 1934.

Appointed Day for the Operation of Certain Provisions.

Whereas by Section Sixteen of the Agricultural Marketing (Pig Industry) Act (Northern Ireland), 1934 (hereinafter referred to as "the Act"), it is provided that except as is otherwise expressly provided in the Act, the Act shall come into operation on the appointed day and the appointed day for the purposes of the Act shall be such day as the Minister of Agriculture may appoint, and different days may be appointed for different purposes and different provisions of the Act.

Now, therefore, I, the Right Honourable Sir Basil Stanlake Brooke, Bart., the Minister of Agriculture for Northern Ireland, hereby order and direct as follows:—

With the exception of Section Five of the Act the provisions of the Act shall come into operation on the first day of January, nineteen hundred and thirty-five.

MILK AND MILK PRODUCTS ACT
(NORTHERN IRELAND), 1934.DETERMINATION OF JOINT MILK
COUNCIL FOR NORTHERN IRELAND.

The Joint Milk Council for Northern Ireland in the exercise of its powers under Section Six of the Milk and Milk Products Act (Northern Ireland), 1934, hereby determines as follows:—

RETAIL PRICES IN NORTHERN IRELAND.

On and after the 23rd day of December, 1934, until the 12th day of May, 1935, milk of Grade A, Grade B and Grade C shall be sold by retail at the following prices in the following areas of Northern Ireland:—

1. The County Borough of Londonderry, the Urban Districts of Carrickfergus and Newtownards, the Rural Districts of Belfast and Castlereagh, the portion of the Larne Rural District comprised in the District Electoral Division of Carrickfergus Rural, and the portions of the Lisburn Rural District comprised in the District Electoral Divisions of Dunmurry, Lambeg, and Malone:

Milk of Grade A—not less than 2/2 per gallon.

Milk of Grade B—2/- per gallon.

Milk of Grade C—1/10 per gallon.

2. The Borough of Coleraine and the Urban Districts of Armagh, Ballycastle, Ballymena, Banbridge, Donaghadee, Enniskillen, Larne, Lurgan, Newcastle, Newry, Omagh, Portadown, Portrush, Portstewart, Strabane, Warrenpoint, and Whitehead:

Milk of Grade A—not less than 2/- per gallon.

Milk of Grade B—not less than 1/10 per gallon.

Milk of Grade C—not less than 1/8 per gallon.

3. All other areas of Northern Ireland for which prices have not been determined under the Determination of the Joint Milk Council for Northern Ireland, dated the 4th day of December, 1934, or under paragraphs 1 and 2 of this Determination:

Milk of Grade A—not less than 1/10 per gallon.

Milk of Grade B—not less than 1/8 per gallon.

Milk of Grade C—not less than 1/6 per gallon.

4. Exceptions:

(i) A daily sale of milk exceeding two gallons to one consumer may be sold at not more than 4d. per gallon less than the retail prices fixed for the area concerned.

(ii) Milk sold to public hospitals by the holder of a producer's licence shall be sold at the prices specified in paragraph 1. of the Determination of the Joint Milk Council for Northern Ireland, dated 4th December, 1934.

(iii) Milk sold by retail from dairies or shops and collected by the purchaser and milk collected by a purchaser at the producer's premises may be sold at not more than 4d. per gallon less than the retail prices fixed for the area concerned.

(iv) The Council may if it deems fit specially exempt any particular class of sale from the operation of the above prices.

CENSUS OF PRODUCTION.

ORDER OF THE MINISTRY OF COMMERCE DATED 12TH DECEMBER, 1934, DETERMINING THAT A CENSUS OF PRODUCTION SHALL BE TAKEN IN THE YEAR 1936.

Whereas by Section 1, sub-section (2) of the Census of Production Act, 1917, it is provided that a Census shall be taken in any year which is fixed for the purpose by an Order made by the Board of Trade and laid before Parliament:

Provided that there is at least a year's interval between the date on which the Order is made by the Board of Trade and the commencement of the year in which the Census is to be taken.

And whereas, by virtue of the provisions of the Government of Ireland Act, 1920, and the several Orders in Council and Orders made thereunder, all the powers and functions of the Board of Trade under the said first mentioned Act, so far as they relate to Northern Ireland, are now transferred to and vested in the Ministry of Commerce (in this Order referred to as "the Ministry").

Now, therefore, the Ministry, in pursuance of the powers conferred upon the Ministry by the said Section 1, sub-section (2) of the Census of Production Act, 1917, and of all other powers enabling the Ministry in that behalf, hereby makes the following Order:—

1. A Census of Production in Northern Ireland shall be taken in the year 1936 in respect of production in the year 1935.

2. This Order may be cited as "The Census of Production (1936) Order (Northern Ireland), 1934."

MILK INDUSTRY ASSISTANCE GRANT.

EQUALISATION PAYMENTS.

The Ministry of Agriculture for Northern Ireland in exercise of the powers conferred on it by sub-section 1 of section 9 of the Milk and Milk Products Act (Northern Ireland), 1934, has amended the Regulations governing the making of equalisation payments in respect of milk produced in Northern Ireland and delivered to a creamery and used for the purpose of the extraction of cream for sale as such or for manufacture into butter. The amending Regulations, which are entitled The Milk (Equalisation Payments) (Amendment) Regulations (Northern Ireland), 1934, came into force on the 21st December, 1934. CATTLE INDUSTRY (EMERGENCY PROVISIONS) ACT, 1934.

Regulations, dated 20th December, 1934, have been made by the Minister of Agriculture and Fisheries and the Secretaries of State concerned with agriculture in Scotland and Northern Ireland, under the Cattle Industry (Emergency Provisions) Act, 1934, amending, with effect from 1st January, 1935, the killing out percentage to which cattle, in respect of which payments may be made under the Act, must conform.

The standard is raised from 52 per cent. to 54 per cent., that is to say, the weight of the dressed carcase as estimated by the Certifying Authority must be in the proportion of 60 lbs. to each hundredweight of the live weight of the animal, instead of 58 lbs. which was the requirement under Article 1 of the Cattle Industry (Emergency Provisions) Regulations, 1934.

RATES OF INTEREST ON GOVERNMENT LOANS.

(i) Agricultural buildings—

Not exceeding 5 years * ... 3 per cent.

(ii) Silos (Wooden) structure—

(E) Sea or Inland Fishery—for the purchase of boats, engines or equipment :—

(1) Not exceeding 5 years * § ... 3 per cent.

(2) Exceeding 5 years * § ... 4 per cent.

(F) Schools :—

(i) Secondary and Preparatory Schools—

To the Governors or Trustees of Preparatory, Intermediate and Secondary Schools, for :—

(1) The purchase and erection of school equipment—

Not exceeding 10 years * ... 4 per cent.

(2) The establishment and equipping of school libraries—

Not exceeding 5 years * ... 4 per cent.

(3) The purchase, erection, extension or alteration of school buildings—

Not exceeding 35 years * ... 4 per cent.

(ii) Public Elementary Schools—

For the purchase, erection or improvement of schools under the Schools and Training Colleges (Ireland) Act, 1884, and the Education Acts (Northern Ireland), 1923-1931—

Not exceeding 35 years * ... 4 per cent.

IV. OTHER LOANS.

The rate of interest to be charged on local, land and works, and development loans other than those defined in Parts I, II, and III of this Notice will be determined by the Ministry of Finance according to the circumstances of each individual case.

NOTE.—METHOD OF REPAYMENT.

Loans marked * above are repayable by an annuity or rent charge, calculated to include interest at the rates specified. Loans

marked § above are repayable by equal half-yearly instalments of the principal advanced, together with interest on the balance from time to time outstanding. Loans marked † above are repayable by annual instalments and interest is paid in advance. The method of repayment of loans under the Drainage Acts (Northern Ireland), 1925 to 1933, will normally be under method §, but in special cases the Ministry may require payment under method *.

THE MERCHANDISE MARKS (IMPORTED GOODS) EXEMPTION DIRECTION (No. 7), 1934, DATED THE EIGHTEENTH DAY OF DECEMBER, 1934, MADE BY THE MINISTER OF AGRICULTURE AND FISHERIES, THE SECRETARY OF STATE FOR THE HOME DEPARTMENT AND THE SECRETARY OF STATE FOR SCOTLAND ACTING JOINTLY UNDER SECTION 3 (1) OF THE MERCHANDISE MARKS ACT, 1926 (16 & 17 GEO. 5, c. 53).

Whereas by Section 3 sub-section (1) of the Merchandise Marks Act, 1926 (16 and 17 Geo. 5, c. 53), it is provided that if, where an Order in Council has been made under that Act with respect to any goods, it is shown to the satisfaction of the Appropriate Department by persons appearing to the Department to have a substantial interest in the matter that the application of the provisions of the Order or of some of those provisions to any particular class or description of those goods has caused or is likely to cause injury or hardship to the said persons or any of them, the Department may direct that the Order or any particular provisions of the Order shall cease to apply to goods of that class or description or shall apply to such goods subject only to such modifications and conditions as the Department think fit, and the Order shall, while the Direction is in force, have effect subject thereto:

And whereas it is provided by Article 1

of the Merchandise Marks (Imported Goods) No. 7 Order, 1934, (a) that it shall not be lawful to import (among other things) any frozen pork or to sell or expose for sale in the United Kingdom (among other things) any imported frozen pork unless such meat bears an indication of origin; and by Article 2 of the said Order that the indication of origin shall be branded, or stamped, stencilled or printed in ink or stain, durably and conspicuously, in letters which shall except as therein provided be not less than one-half of an inch in height; and by Paragraphs III and IV of Article 3 of the said Order that the indication of origin required on importation shall be applied as follows, that is to say—

III. In the case of frozen pork, each carcase shall bear the indication of origin on each side of the carcase on the outer side of the leg, loin, fore-end (spare-rib and blade-bone) and hand-and-spring, composing four marks on each side in the positions shown in the diagram, Figure III, in the Schedule to the Order.

IV. Except where any portion of a carcase of frozen pork is one of the forms of meat specified in the next following paragraph of the Order, each portion of any such carcase shall bear such markings indicative of origin as it would have borne if it had formed part of a complete carcase of such meat which had been marked in the manner hereinbefore in the Article prescribed.

and by Paragraph I of Article 4 of the said Order, that the indication of origin required on sale and exposure for sale, whether wholesale or by retail, shall be applied as follows, that is to say—

I. In the case of frozen pork, in like manner as on importation.

And whereas it is provided by Article 7 thereof that the said Order shall come into force at the expiration of six months from the date thereof and the said Order will accordingly come into force on the 7th January, 1935:

And whereas the Minister of Agriculture and Fisheries, the Secretary of State for the Home Department and the Secretary of State for Scotland, acting jointly, being the Appropriate Department in this case, having considered representations made to them in that behalf by persons appearing to the Department to have a substantial interest in the matter, are satisfied that the application of the aforesaid provisions of Articles 3 and 4 of the said Order to certain portions of carcasses of frozen pork, namely, frozen shoulder cuts of pork from which the skin has been removed prior to importation, is likely to cause hardship to the said persons:

Now, therefore, the Minister of Agriculture and Fisheries, the Secretary of State for the Home Department and the Secretary of State for Scotland, acting jointly, in pursuance of the powers conferred upon them by the said Section 3, hereby direct as follows:—

1. The aforesaid provisions of Paragraph IV of Article 3 and Paragraph I of Article

4 of the Order shall not apply to shoulder cuts of frozen pork from which the skin has been removed prior to importation; and

2. The provisions of Paragraph V of Article 3 and Paragraph II of Article 4 shall apply to such meat as though the description "shoulder cuts of frozen pork from which the skin has been removed prior to importation" had been added to the forms of meat specified in these paragraphs.

3. This Direction may be cited as the Merchandise Marks (Imported Goods) Exemption Direction (No. 7), 1934.

Whereas by Section 3, sub-section (1) of the Merchandise Marks Act, 1926 (16 & 17 Geo. 5, c. 53), it is provided that if, where an Order in Council has been made under that Act with respect to any goods, it is shown to the satisfaction of the Appropriate Department by persons appearing to the Department to have a substantial interest in the matter that the application of the provisions of the Order or of some of those provisions to any particular class or description of those goods has caused or is likely to cause injury or hardship to the said persons or any of them, the Department may direct that the Order or any particular provisions of the Order shall cease to apply to goods of that class or description or shall

apply to such goods subject only to such modifications and conditions as the Department think fit, and the Order shall, while the Direction is in force, have effect subject thereto:

And whereas the Minister of Agriculture and Fisheries, the Secretary of State for the Home Department and the Secretary of State for Scotland, acting jointly, being the Appropriate Department in this case, having considered representations made to them in that behalf by persons appearing to the Department to have a substantial interest in the matter, are satisfied that the application of the aforesaid provisions of Article 1 of the said Order to whole carcasses of frozen pork imported before the 7th January, 1935 (the date on which the said Order will come into force) is likely to cause hardship to the said persons:

Now, therefore, the Minister of Agriculture and Fisheries, the Secretary of State for the Home Department and the Secretary of State for Scotland, acting jointly, in pursuance of the powers conferred upon them by the said Section 3, hereby direct as follows:—

1. Without affecting the operation of the provisions of the said Article 1 of the Merchandise Marks (Imported Goods) No. 7 Order, 1934, requiring an indication of origin on importation, the provisions of the said Article 1 requiring an indication of origin on sale or exposure for sale shall not apply to whole carcasses of frozen pork before the 28th February, 1935.

2. This Direction may be cited as the Merchandise Marks (Imported Goods) Exemption Direction (No. 6), 1934.
