FORASMUCH as a Bill has been passed by the Scottish Parliament and has been submitted to Us for Our Royal Assent by the Presiding Officer of the Scottish Parliament in accordance with the Scotland Act 1998 the short Title of which Bill is set forth in the Schedule hereto but that Bill by virtue of the Scotland Act 1998 does not become an Act of

The Department proposes to amend the gas conveyance element of the Phoenix Natural Gas Limited combined licences for the conveyance and supply of gas in Northern Ireland granted to Phoenix Natural Gas Limited (hereinafter referred to as the "licensee").

Directive 2003/55/EC required the separation of gas distribution and supply functions within Phoenix Natural Gas. This resulted in the establishment of Phoenix Supply Limited as a separate gas supply company. Amendments are therefore necessary to the conveyance element of the combined licences in order to remove references to gas supply activities.

As part of the agreement reached with the licensee in November 2006 to reform their regulatory regime, it was agreed that the licensee would sell its transmission business. The sale of the Phoenix Transmission asset in March 2008 therefore requires amendments to the conveyance element of the combined licences.

THE SURFACE WATERS (SHELLFISH) (CLASSIFICATION) (AMENDMENT) REGULATIONS (NORTHERN IRELAND) 2009

The Department of the Environment has made a Statutory Rule entitled "The Surface Waters (Shellfish) (Classification) (Amendment) Regulations (Northern Ireland) 2009" (S.R. 2009 No. 61).

The Rule comes into operation on 27 March 2009.

The Rule, which is made under powers conferred by Articles 5 and 36 of the Water (Northern Ireland) Order 1999 and section 2(2) of the European Communities Act 1972, applies the requirements of the codified European Directive No 2006/113/EC concerning the quality of shellfish waters to Northern Ireland.

- (b) have their account transferred to a different bank.

This is the first objective of the insolvency process.

The procedure can only be initiated by the Bank of England, the Financial Services Authority or the Department by application to the court. The court then makes a bank insolvency order, appointing a bank liquidator. In the initial stages, the bank liquidator is accountable to a liquidation committee formed of the FSA, the Bank of England and the FSCS.

Once the bank liquidator considers that the first objective is achieved, the liquidation committee will pass a resolution to that effect and the bank insolvency will move to the second objective which is to wind up the affairs of the bank so as to achieve the best results for the creditors as a whole.

These terms and conditions ("Terms and Conditions") govern submission

By submitting Notices howsoever communicated, whether at the website www.gazettes-online.co.uk (the "Website") or to www.gazette-submission.co.uk, email, post and/or facsimile, the Advertiser (as defined below) agrees to be bound by these Terms and Conditions.

The Publisher reserves the right to modify these Terms and Conditions at any time. Such modifications shall be effective immediately upon publication of the modified Terms and Conditions. By submitting Notices to the Belfast Gazette after the Publisher has published notice of such modifications, the Advertiser agrees to be bound by the revised Terms and Conditions.

1 Definitions

- In these Terms and Conditions:
