THE TRAVELLING EXPENSES AND REMISSION OF CHARGES (AMENDMENT No. 3) REGULATIONS (NORTHERN IRELAND) 2009

Notice is given that the Department of Health, Social Services and Public Safety, in exercise of the powers conferred by Articles 45, 98, 106 and 107(6) of, and paragraphs 1(b) and 1B of Schedule 15 to, the Health and Personal Social Services (Northern Ireland) Order 1972 has made a statutory rule entitled the Travelling Expenses and Remission of Charges (Amendment No. 3) Regulations (Northern Ireland) 2009.

These Regulations further amend the Health and Personal Social Services Travelling Expenses and Remission of Charges Regulations (Northern Ireland) 2004, which provide for remission and payment of certain charges which would otherwise be payable under the Health and Personal Social Services (Northern Ireland) Order 1972 and for

payment by the Department of Health, Social Services and Public Safety of travelling expenses incurred in attending a hospital.

In calculating a person's resources and requirements under the principal Regulations in order to establish whether a person can claim entitlement to remission of Health Service charges and the payment of Health Services travelling expenses, a modified version of the Income Support (General) Regulations 1987 is used, as set out in Schedule 1 to the principal Regulations.

These regulations update the reference to the publication which describes additional loans paid under the Education (Student Loans) (Scotland) Regulations 2007. These loans are disregarded in the calculation of a student's loan income when a person's entitlement to remission of Health Service charges and the payment of Health Services travelling expenses is being established under the principal Regulations.
