A PROCLAMATION

FOR APPOINTING MONDAY, MAY 6TH, A BANK HOLIDAY AND A PUBLIC HOLIDAY THROUGHOUT THE UNITED KINGDOM.

GEORGE R.I.

Whereas We consider it desirable that Monday, the Sixth day of May next, being the occasion of the Twenty-fifth Anniversary of Our Accession to the Throne, should be observed as a Bank Holiday and as a Public Holiday throughout the United Kingdom:

And whereas the said Sixth day of May is a Bank Holiday in Scotland under the provisions of the Bank Holidays Act, 1871:

We do hereby, by and with the advice of Our Privy Council, in exercise of the powers conferred by the Bank Holidays Act, 1871, appoint Monday the Sixth day of May next to be observed as a Bank Holiday throughout England, Wales and Northern Ireland.

And We do further appoint the said Sixth day of May next to be observed as a Public Holiday throughout the United Kingdom and by this Our Royal Proclamation command the said day to be so observed, and all Our loving subjects to order themselves accordingly.

Given at Our Court at Buckingham Palace this twenty-first day of February, in the year of our Lord One thousand nine hundred and thirty-five, and in the twenty-fifth year of Our Reign. SHOPS ACT, 1912.

#### CIVIL AUTHORITIES (SPECIAL POWERS) ACTS (NORTHERN IRELAND), 1922 and 1933.

I, the Right Honourable Sir Richard Dawson Bates, Minister of Home Affairs for Northern Ireland, by virtue of the powers vested in me by the Civil Authorities (Special Powers) Acts Northern Ireland), 1922 and 1933, and of all other powers enabling me in this behalf, do hereby delegate unconditionally to the following Police Officer, namely, Ewing Gilfillan, Esquire, County Inspector, Royal Ulster Constabulary, all the powers vested in me as Civil Authority under Regulation 23 of the Regulations made under the said Statutes, to exercise concurrently with me and with any other person or persons to whom a similar delegation may have been or may hereafter be made the said powers throughout the whole of Northern Ireland, such delegation to continue until revoked, and the said Police Officer shall for the purpose of the said Regulation be concurrently with me and such other person or persons the Civil Authority for the whole of Northern Ireland.
