NATIONAL HEALTH INSURANCE AND CONTRIBUTORY PENSIONS.

EXTENSION OF ENACTMENTS.

MOTOR VEHICLES (INTERNATIONAL RACE) ACT (NORTHERN IRELAND), 1935.

(1) In accordance with the provisions of the above mentioned Act, and having been duly authorised by the Ministry of Home Affairs for Northern Ireland, I hereby declare that the Race Area shall be the Area enclosed by joining the following points:—

(2) Entry to the Race Area will be permitted by the following roads only:

The Newtownards-Donaghadee Road. The Newtownards-Greyabbey Road.

The Comber-Killyleagh Road.

- (3) Drivers in charge of motor vehicles will be required to display the prescribed badge at all times on the roads mentioned in para. 2, and within the Race Area.
- (4) The prescribed badge shall be displayed on right hand or off side of windscreen of all motor vehicles within the Race Area during the period commencing at midnight on Friday, 6th September, 1935, and ending at 5 p.m. on Saturday, 7th September, 1935.
- (5) The prescribed badge, for which the charge is 2/6, can be obtained from the Ulster Tourist Trophy Race Committee, Chichester Street, Belfast.
- (6) Payment of the price fixed for the required badge shall not be required in connection with the following:-
 - (a) Motor Vehicles which are the property of the Crown.
 - (b) Omnibuses used to operate regular scheduled services, which are not being provided in connection with the Race.
 - (c) Motor Vehicles in respect of which the Inspector General, Royal Ulster Constabulary has been satisfied that they are usually kept within the Race Area.
 - (d) Motor Vehicles that are entering or leaving the Race Area for purposes other than purposes of the International Motor Race.

Applications for issue of badges free of charge should be made in the case of motor vehicles under Clauses (a), (b), and (d) to the District Inspector, R.U.C., Newtown-ards, and in the case of motor vehicles under Clause (c) to the Sergeant in charge of the Police Station of the Sub-District in which the vehicle is usually kept.

BOOT & SHOE REPAIRING TRADE BOARD (NORTHERN IRELAND).
