GREETING:

FORASMUCH as a Bill has been passed by the Scottish Parliament and has been submitted to Us for Our Royal Assent by the Presiding Officer of the Scottish Parliament in accordance with the Scotland Act 1998 the short Title of which Bill is set forth in the Schedule hereto but that Bill by virtue of the Scotland Act 1998 does not become an

Act of the Scottish Parliament nor have effect in the Law without Our Royal Assent signified by Letters Patent under Our Scottish Seal (that is Our Seal appointed by the Treaty of Union to be kept and used in Scotland in place of the Great Seal of Scotland) signed with Our own hand and recorded in the Register of the Great Seal We have therefore caused these Our Letters Patent to be made and have signed them and by them do give Our Royal Assent to that Bill **COMMANDING ALSO** the Keeper of Our Scottish Seal to seal these Our Letters with that Seal.

The Northern Ireland Executive's strategic aim is for a more sustainable energy system in which energy is used as efficiently as possible; where much more of our energy is from renewable sources; and where energy is as competitively priced as possible. The Executive's Strategic Energy Framework (SEF) envisions Northern Ireland's energy future over years to 2020 with the key energy goals of building competitive markets, ensuring security of supply, enhancing sustainability and developing our energy infrastructure.

In order to pursue these goals, and aid delivery of the SEF, the Department proposes to ask the Northern Ireland Assembly to make new primary legislation, to allow for greater powers for sustainable energy and additional regulatory measures relating to natural gas and electricity.

GENERAL NOTICE NO: 1151

I, David Fisher, Director of the Consumer Credit Group in the Office of Fair Trading ('the OFT') and a member of the OFT's staff, being authorised in that respect in writing by the OFT pursuant to paragraph 12 of Schedule 1 to the Enterprise Act 2002, hereby give general notice pursuant to section 22(8) of the Consumer Credit Act 1974 that under section 22(1)(b) of that Act the OFT has varied the group licence for Liquidators and Receivers.

The group licence is in respect of people appointed or otherwise authorised under the legislation specified in the schedule who also hold a standard consumer credit licence.

The licence is to carry on the business of: consumer credit, consumer hire, credit brokerage, debt-adjusting, debt-counselling, debt-collecting, debt administration, provision of credit information services and the operation of a credit reference agency.

The licence is limited to the activities carried on by members of the group in pursuance of the duties imposed upon them by virtue of an appointment, appointments or authorities specified in the Schedule.

The validity of the licence is not limited to any specified period of time.

Schedule

The group shall consist of any individual who holds a licence, under the Consumer Credit Act, or who is a member of a partnership holding a licence, or who is a licensee under a group licence and who is appointed to be:

- i. a liquidator under Part IV to Part VI of the Insolvency Act 1986 and/or under the Insolvent Partnerships Order 1994, or under Part V to Part VII of the Insolvency (Northern Ireland) Order 1989 and/or under the Insolvent Partnerships Order (Northern Ireland) 1995 an administrator under Schedule B1 of the Insolvency Act 1986 or Schedule B1 of the Insolvency (Northern Ireland) Order 1989, a receiver and/or manager (including Administrative Receiver) under Part III of the Insolvency Act 1986 or Part IV of the Insolvency (Northern Ireland) Order 1989 of a body corporate or an unincorporated body of persons.
- ii. an executor, administrator, trustee under the Administration of Insolvent Estates of Deceased Persons Order 1986 or the Administration of Insolvent Estates of Deceased Persons Order (Northern Ireland) 1991, receiver, manager or judicial factor of the estate of a deceased person.
- iii. a trustee in bankruptcy under Part IX of the Insolvency Act 1986 or Part IX of the Insolvency (Northern Ireland) Order 1989.
- iv. a trustee under the Insolvent Partnerships Order 1994 or the Insolvent Partnerships Order (Northern Ireland) 1995.
- v. a deputy under section 16 of the Mental Capacity Act 2005 to carry on the affairs of a person who lacks capacity.
- vi. a person authorised in Northern Ireland under Part VIII of the Mental Health Act (NI) Order 1986 to carry on the business of a person who is incapable, by reason of mental disorder, of managing and administering his property and affairs.
- vii. a person appointed under section 57 of the Adults with Incapacity (Scotland) Act 2000 as a guardian in relation to an adult's property, financial affairs or personal welfare.
- viii. a trustee under or in pursuance of:

DEPARTMENT FOR SOCIAL DEVELOPMENT**LICENSING (REQUIREMENTS FOR CONFERENCE CENTRE (AMENDMENT) REGULATIONS (NORTHERN IRELAND) 2012**

The Department for Social Development has made a Statutory Rule entitled "The Licensing (Requirements for Conference Centre) (Amendment) Regulations (Northern Ireland) 2012" (S.R. 2012 No.249) which comes into operation on 1st September 2012.

The Rule amends the Licensing (Requirements for Conference Centre) Regulations (Northern Ireland) 1997, which set out the conditions to which premises must conform before they may be awarded a certificate by the Northern Ireland Tourist Board for the purpose of securing a licence for the sale by retail of intoxicating liquor. It replaces the requirement that a conference centre must have a fire certificate issued by the Fire Authority for Northern Ireland (now known as the Northern Ireland Fire and Rescue Service), or a letter from an authorised member of the fire brigade in relation to the adequacy of the fire safety measures in the premises with a requirement that it has an assessment pursuant to the provisions of Articles 25 and 26 of The Fire and Rescue Services (Northern Ireland) Order 2006.

DEPARTMENT OF HEALTH, SOCIAL SERVICES AND PUBLIC SAFETY**THE OPTICAL CHARGES AND PAYMENTS (AMENDMENT) REGULATIONS (NORTHERN IRELAND) 2012**

Notice is given that the Department of Health, Social Services and Public Safety, in exercise of the powers conferred by Articles 62, 98, 106 and 107(6) of, and Schedule 15 to, the Health and Personal Social Services (Northern Ireland) Order 1972 has made a statutory rule entitled the Optical Charges and Payments (Amendment) Regulations (Northern Ireland) 2012.

These Regulations further amend the Health and Personal Social Services (Optical Charges and Payments) Regulations (Northern Ireland) 1997 ("the principal Regulations") which provide for payments to be made, by means of a voucher system, in respect of costs incurred by certain categories of persons in connection with the supply, replacement and repair of optical appliances.

Regulation 2 amends regulation 19 of the principal Regulations to increase the redemption value of a voucher issued towards the cost of replacement of a single contact lens and to increase the maximum contribution by way of a voucher to the cost of repair of a frame.

Regulation 3 and the Schedule amend the Schedules to the principal Regulations. Firstly, it omits paragraph 10 in Schedule 1; secondly the value of vouchers issued towards the costs of the supply and replacement of glasses and contact lenses is increased; thirdly, the additional values for vouchers for prisms, tints, photochromic lenses and special categories of appliances are increased; and fourthly, the value of vouchers issued towards the cost of the repair and replacement of optical appliances is increased.

Regulation 4 provides that the increases contained in regulation 2(a), 3 and 4 apply only in relation to vouchers accepted or used on or after 1st August 2012.

- 4.4 Notices can be edited to re-position material for style;
- 4.5 any additions or deletions required in order to include the minimum necessary information set out in any Notice guidelines shall be confirmed with the Advertiser; and
- 4.6 no amendments to the text (other than those made as a consequence of 4.1-4.5 above) shall be made without written confirmation from the Advertiser.

8 Where the Publisher is responsible for any error which, in the Publisher's reasonable opinion, causes a substantive change to the meaning of a Notice or would affect the legal efficacy of a Notice, upon notification of such error by the Advertiser, the Publisher shall publish the corrected Notice at no charge and at the next suitable opportunity and this shall be the limit of the Publishers liability or responsibility in these circumstances.

10 The location of the Notice in the Belfast Gazette shall be at the discretion of the Publisher. For the avoidance of doubt, the Notice shall be published in the house style of the Belfast Gazette.

12 To the extent permissible by law the Publisher excludes all implied warranties, conditions or other terms, whether implied by statute or otherwise.

13 The Advertiser agrees to indemnify and hold the Publisher and/or (as applicable) the Publisher's affiliates, officers, directors, agents and employees harmless from all losses incurred (including legal costs), in respect of any claim or demand, including threatened claims or demands, made by any third party which constitute, or would if proved constitute, a breach or threatened breach by the Advertiser of these Terms and Conditions or any breach by the Advertiser of any law or an infringement of the rights of a third party. The Publisher shall consult with the Advertiser as to the way in which such claims are handled but the Publisher retain the final decision on all aspects of the claim, including choice of instructing solicitors, steps taken in litigation and decisions to settle the case. The Advertiser shall provide, at its own expense, such co-operation and assistance as the Publisher may reasonably request, including the provision of witnesses, access to premises and delivery up of documents.

14 The Advertiser shall promptly notify the Publisher in writing of any actual, threatened or suspected claim made by a third party or parties against the Advertiser and/or the Publisher in relation to a Notice. The Publisher reserves the right, following a claim or threatened claim, to immediately remove the Notice which is the subject of the complaint from the website at www.gazettes-online.co.uk and all other websites controlled by the Publisher containing the Notice. The Publisher may require the Advertiser to amend the Notice at its own cost before it agrees to re-publish the Notice if it is capable of rectification to avoid the claim or threatened claim. Any reinstatement of the Notice shall be at the sole discretion of the Publisher.

15 The Advertiser acknowledges that the Publisher may re-use Notices and/or allow third parties to re-use Notices accepted for publication in the Belfast Gazette, and hereby assigns to the Publisher all rights, including but not limited to, copyright in all Notices, and warrants that any such activity by the Publisher and/or third parties does not and will not infringe any legal right of the Advertiser or any third party.

The Charges must be paid by the Advertiser in advance of publication unless other requirements of the Publisher (as determined from time to time) are notified to the Advertiser.

18 If the Advertiser wishes to make a Complaint then please refer to the Gazette office.

19 A person who is not a party to these Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act 1999 to enforce any term of these Terms and Conditions but this does not affect any right or remedy of a third party specified in these Terms and Conditions or which exists or is available apart from that Act.

20 These Terms and Conditions and all other express terms of the contract shall be governed and construed in accordance with the Laws of England and the parties hereby submit to the exclusive jurisdiction of the English courts.


