ABANDONMENT ORDERS

The Department for Regional Development has made a Statutory Rule entitled The M3 Motorway at Titanic Quarter Railway Station, Belfast (Abandonment) Order (Northern Ireland) 2012 (S.R. 2012 No. 274), which comes into operation on 30th July 2012.

The Rule will abandon an area of 1151 square metres of road situated between the south-eastern side of the M3 Motorway and Titanic Quarter Railway Station.

NOTICE OF STATUTORY POLICY CONSULTATION ON THE INTRODUCTION OF ELECTRICITY DISTRIBUTION LICENSING EXEMPTIONS AND THE IMPOSITION OF OBLIGATIONS ON LICENCE EXEMPT DISTRIBUTORS AND SUPPLIERS.

The Department of Enterprise, Trade and Investment (hereinafter referred to as "the Department") hereby gives the following notice:

In 2011, as part of transposition of the EU Third Energy Package, the Department made the Gas and Electricity (Internal Markets) Regulations (Northern Ireland) 2011 which made electricity distribution a separate licensable activity in Northern Ireland for the first time. The prohibition on carrying out the activity of electricity distribution without a licence will commence from 30th April 2013.

The Department now proposes to make new secondary legislation related to the electricity industry in Northern Ireland, aspects of which will implement certain requirements of the EU Third Energy Package in Northern Ireland, including the introduction of electricity distribution licensing exemptions and the imposition of obligations on licence exempt distributors and suppliers.

In this consultation, the Department seeks views on the electricity distribution licensing exemptions which should apply in Northern Ireland. The Department also seeks comments on the proposed imposition of obligations on licence exempt electricity distributors and suppliers in Northern Ireland as outlined in the consultation paper, and which stem from the requirements of the Electricity Directive.

Entities currently distributing electricity in Northern Ireland which will be affected by these proposals may include the following categories:

- industrial/ manufacturing companies;
- large commercial (e.g. larger businesses, ports, airports, bus and train facilities);
- small commercial (e.g. office facilities, smaller shopping developments, smaller industrial estates, caravan sites, marinas, larger scale farms or other agricultural usage etc.); and
- public sector organisations (e.g. Department of Regional Development Roads Service in respect of their street lighting network, and perhaps NI Water. Also other government entities such as Department of Agriculture and Rural Development in relation to their agricultural and forestry facilities, District Councils, Health Trusts/hospitals, and universities and schools).

Entities currently supplying electricity in Northern Ireland and benefiting from an exemption from the requirement to hold a supply licence under the Electricity (Class Exemption from the Requirement for a Licence) Order (Northern Ireland) 1999 will also be affected by the proposals.

GAS AND ELECTRICITY (INTERNAL MARKETS) REGULATIONS 2011

REGULATION 32 – NOTICE OF DETERMINATION OF NEW DATE ON WHICH THE PROHIBITION ON DISTRIBUTING ELECTRICITY WITHOUT A LICENCE WILL HAVE EFFECT.

Notice is hereby given that the Department of Enterprise, Trade and Investment, in exercise of the power conferred on it by Regulation 32 of the Gas and Electricity (Internal Markets) Regulations (Northern Ireland) 2011, has determined that the requirements of Article 8(1)(bb) of the Electricity (Northern Ireland) Order 1992 shall not apply to any person, other than those noted in Regulation 31 of the above Regulations, until 30 April 2013.

This represents a seven month extension of the suspension of the prohibition on undertaking the activity of electricity distribution without a licence.

In July 2012, the Department will commence a public consultation exercise on the distribution exemptions which should apply in Northern Ireland and on certain obligations which will apply to licence exempt electricity distributors and suppliers to comply with European legal requirements.
