### MILK AND MILK PRODUCTS ACT (NORTHERN IRELAND), 1934.

Whereas it is provided by Section five of the Milk and Milk Products Act (Northern Ireland), 1934, that for the purposes of that Act there shall be established a body to be called the Joint Milk Council for Northern Ireland (hereinafter referred to as "the Council") which shall be a body corporate with perpetual succession and a common seal, and with power to acquire and hold land without licence in mortmain :

### ROAD AND RAILWAY TRANSPORT ACT (NORTHERN IRELAND), 1935.

#### POOLING OF RECEIPTS.

Whereas it is enacted in effect by sub-section (8) of section 14 of the Road and Railway Transport Act (Northern Ireland), 1935 (in this Order referred to as "the Act"), that the pooling scheme framed in accordance with the provisions of the First Schedule to the Act and confirmed or settled in accordance with the provisions of section 14 of the Act shall notwithstanding anything in the Act or in any other enactment limiting the powers of the Northern Ireland Road Transport Board established under section 1 of the Act or of any of the railway companies referred to in sub-section (1) of section 14 of the Act be or

be deemed to have been of full force and effect as from such day, not later than twelve months after the passing of the Act, as may be appointed by the Minister of Home Affairs.

Now, therefore, I, The Right Honourable Sir Richard Dawson Bates, Minister of Home Affairs for Northern Ireland, in exercise of all powers in this behalf enabling me, hereby order and appoint that the pooling scheme framed in accordance with the provisions of the First Schedule to the Act and confirmed or settled in accordance with the provisions of section 14 of the Act shall be or be deemed to have been of full force and effect as from the 1st day of January, 1936.

#### WILD BIRDS PROTECTION ACT (NORTHERN IRELAND), 1931.
