mined from time to time by the Council in respect of pigs classified under each of the weight classes and grades prescribed in Part II of the Pigs Marketing (Grading) (Northern Ireland) Order, 1935, dated 21st December, 1935.

From the first day of January, 1936, until further notice the price per dead cwt. in respect of pigs included in each of the weight classes and grades prescribed in Part II of the above-mentioned Order shall be as follows:—

The price payable for a pig carcase certified by the Ministry's grader as unsuitable for the manufacture of Wiltshire bacon shall be 5/- below the Standard Price.

The prices for pigs sold under direct contract to Wiltshire curers shall at no time during 1936 be less than the prices specified in the table above, but may be at such higher figures as may subsequently be determined by the Council. In the case of pigs sold to the Pigs Marketing Board (Northern Ireland) and resold to Wiltshire curers the prices shall be such as may be determined by the Council from time to time, provided that the price paid by the Board shall at no time exceed the price payable to producers for pigs sold under direct contract to Wiltshire curers. the first day of January, 1936, until further notice such prices shall be in accordance with the table above, provided that pigs sold alive to the Pigs Marketing Board (Northern Ireland) may be paid for on the basis of a live weight price per cwt. equivalent to the corresponding dead weight price per cwt. as specified above.

## (d) For pigs sold alive to the Pigs Marketing Board (Northern Ireland) and not resold to Wiltshire curers.

On the basis of a live weight price per cwt. equivalent to the corresponding dead pig price.

Provided that the Pigs Marketing Board (Northern Ireland) may reduce the price payable for pigs by a sum not exceeding 5/per cwt. live weight or such other amount as the Council may from time to time determine.

## II. TERMS OF SALE.

In the case of a graded pig carcase the amount to be paid shall be the product (to

the nearest penny) of the dead weight of the pig and the relevant Grade or other price per dead cwt. as published in the appropriate ready reckoner issued by the Council, less any prescribed deduction or cut.

The curer shall issue to the producer a carcase card in respect of each pig bought and shall issue such carcase card free of charge before the producer slaughters the pig.

The producer shall, unless prevented by the Public Health Authorities, deliver the pig in accordance with the terms set out on the said carcase card and in accordance with the arrangements hereinafter set forth, and the curer shall take delivery when the pig is so presented to him by the producer.

The producer shall be entitled to deliver dead pigs to the curer at the producer's nearest recognised pork market or other local collecting centre and the curer shall pay all transport and handling costs subsequent to such delivery. Where a producer delivers dead pigs to a curer's store which is not convenient to the producer's country delivery point, the curer shall pay all the transport charges incurred by the producer, unless it has been the custom for the producer to deliver his dead pigs at the curer's store.

The producer shall pay for the weighing of dead pigs at markets. The curer shall not charge for weighing done at his store except in the case of a store situated in an area where a special charge is required to be paid under an existing statute, legal right or Charter.

The producer may request payment direct by post from the curer and the curer shall comply with such request within four days, or if the producer so requests the curer shall
