Bacon Curer (hereinafter called "the Curer," which expression shall include his/their executors, administrators, successors and/or assigns where the context so requires or admits).

(c) the Pigs Marketing Board (Northern Ireland) (hereinafter called the "Board") whose official address is 36 Victoria Square, Belfast.

WHEREBY IT IS AGREED as follows:—

I. Subject as hereinafter provided the Producer agrees with the Curer and the Board to sell to the Curer, and the Curer agrees with the Producer and the Board to buy from the Producer during the following periods pigs of the Large White York type weighing from 1 cwt. 0 qr. 14 lb. to 1 cwt. 2 qr. 7 lb. dead weight to the numbers hereinafter mentioned.

The total number of pigs delivered under this Contract shall not exceed or be below the total number of pigs hereby agreed to be sold by more than 10 per cent., provided always that the Producer may during any month deliver a number of pigs up to 20 per cent. above or below the number hereby agreed to be delivered in that month.

Where the Producer, owing to circumstances outside his control, finds that he will be unable to deliver the minimum number of pigs for any month, he may, on giving notice in writing to the curer before the 21st day of that month, delay delivery until not later than the 10th day of the month following, but will be paid for the pigs so delivered at the prices ruling for the month in which the pigs were contracted to be delivered.

II. Delivery and Transport. (a) Pigs contracted for shall be transported from the Producer's premises and the delivery shall be effected in accordance with one of the following options:—

- (i) Delivered by Producer at Railway Station named
- (ii) Collected by the Railway Company at Producer's premises at
 and delivered at Curer's factory, abattoir, slaughter house, or receiving depot at

- (iii) Delivered by producer at Curer's factory, abattoir, slaughter house, or receiving depot, at

Provided always that options (ii), (iii) and (iv) above shall apply only to pigs to be transported from a place within 15 miles' radius of the Curer's factory, measured in a direct line, unless otherwise agreed with the Railway Company.

(b) The cost of transport of all pigs from the point of delivery to the Curer's factory shall be paid by the Curer in accordance with the terms of the agreement made between the Board and the Railway Companies. Where a Producer delivers pigs under this Contract throughout by road from a distance within 15 miles' radius of the Curer's factory he shall be paid the following rates by the Curer:—
