The Order will create parking places with unlimited waiting at Belfast: Strandburn Drive in front of No. 79; Castlewellan: Main Street in front of Post Office; Crossgar: Killyleagh Street in front of No. 70; Downpatrick: Saul Street in front of No. 138; Dundonald: Enler Park in a lay-by to the side of No. 2 Enler Close; Dundrum: Church Avenue opposite No. 49; Lisburn: Ashmount Park in front of No. 13; Millisle: Seaview Avenue in front of No. 16; Newtownards: Movilla Street in front of No. 55; Orchard Avenue in a lay by in front of No. 2 and in a lay-by in front of No. 7; Newtownhamilton: Dundalk Street in front of No. 23; Warrenpoint: Great George's Street (South) opposite No. 20.

The Order will create parking places with waiting limited to 3 hours Monday to Saturday 8.30 a.m. to 5.00 p.m. with no return within 1 hour at Ballynahinch: High Street in front of No. 27 and Main Street in front of No. 28 (which replaces an existing parking place with unlimited waiting) and waiting limited to 3 hours on all days 11.00 a.m. to 6.00 p.m. with no return within 1 hour at Newcastle: Main Street in front of No. 14 (which replaces part of a taxi stand).

The Order will amend the description of a parking place at Warrenpoint: Great Georges Street (South) in front of No. 2;

All parking places are for the use of disabled persons' vehicles only. The Department of Agriculture and Rural Development has made a Statutory Rule entitled "The Common Agricultural Policy Single Payment and Support Schemes (Cross Compliance) (Amendment) Regulations (Northern Ireland) 2014". (S.R. 2014 No.1), which comes into operation on 10 February 2014.

This rule gives effect to a change in the underpinning European legislation which removes the Protection of Groundwater against Pollution Statutory Management Requirement (SMR) from the list of SMRs and instead makes it a Standard of Good Agricultural and Environmental Condition.

As a result of this change the Competent Control Authority for this area of Cross-Compliance (the Department of the Environment) must be designated as the Competent Control Authority for the new Protection of Groundwater against Pollution GAEC.
