URBAN DISTRICT OF DONAGHADEE.

Whereas the Ministry of Home Affairs for Northern Ireland by an Order under

- 2. On the 15th day of May, 1936, there shall be elected twelve urban district councillors for the area consisting of the urban district of Donaghadee, and the urban district councillors so elected shall come into office on the 16th day of May, 1936
