THE HEALTH AND SOCIAL CARE (DISCIPLINARY PROCEDURES) (AMENDMENT) REGULATIONS (NORTHERN IRELAND) 2015

The Department of Health, Social Services and Public Safety has made a Statutory Rule entitled "The Health and Social Care (Disciplinary Procedures) (Amendment) Regulations (Northern Ireland) 2015" (S.R. 2015 No. 205), which comes into operation on 23rd April 2015.

This Rule corrects minor drafting errors in the Health and Social Care (Disciplinary Procedures) Regulations (Northern Ireland) 2014 which provide for the investigation and determination by the Regional Health and Social Care Board of questions whether chemists, dentists, ophthalmic medical practitioners and opticians providing services under Part VI of the Health and Personal Social Services Order (Northern Ireland) 1972 have failed to comply with their terms of service, and for the consideration and determination of appeals.
