In tandem with the Scheme but as a separate process, it is proposed that HSBC Trust Company (UK) Limited

('HTCU') will divest itself of its unit trust pension business by initiating a winding up exercise.

Following the sanctioning of the Scheme by the High Court, benefits in HTCU's unit trust pension schemes will be replaced by "buy-out" pension policies issued by HSBC Life and these policies will then be transferred with certain other parts of HSBC Life's pensions business by the Scheme (see 1a above).

A copy of the report on the terms of the Scheme prepared by an Independent Expert in accordance with section 109 of the Act (the 'Scheme Report'), the Scheme guides containing a statement setting out the terms of the Scheme and a summary of the Scheme Report, and the Scheme document may be obtained free of charge by contacting HSBC Life using the telephone number or address set out below. 4.5 any additions, amendments or deletions required in order to include the minimum necessary information set out in any Notice guidelines shall be confirmed with the Advertiser; and

4.6 subject to clause 5 below, no amendments to the text (other than those made as a consequence of 4.1 - 4.5 above) shall be made without confirmation from the Advertiser.
