PROCLAMATIONS

BY THE QUEEN A PROCLAMATION DETERMINING THE SPECIFICATIONS AND DESIGN FOR TEN POUND COINS COMMEMORATING THE FOUR HUNDREDTH ANNIVERSARY OF THE DEATH OF WILLIAM SHAKESPEARE ELIZABETH R.

Whereas under section 3(1)(a), (b), (c), (cc), (cd) and (d) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to determine the denomination, the design and dimensions of coins to be made at Our Mint, to determine the weight and fineness of certain gold coins, the remedy to be allowed in the making of such coins and their least current weight, and to determine the weight and composition of coins other than gold coins or coins of silver of Our Maundy money and the remedy to be allowed in the making of such coins, and to provide for the manner of measurement of the variation from the standard weight for coins:

And Whereas under section 3(1)(ff) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to direct that any coin shall be legal tender for the payment of any amount:

And Whereas it appears to Us desirable to order that, to commemorate the four hundredth anniversary of the death of William Shakespeare, there should be made at Our Mint coins of the denomination of ten pounds in gold and in silver:

We, therefore, in pursuance of the said section 3(1)(a), (b), (c), (cc), (cd), (d) and (ff), and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

GOLD COIN

1. (1) A new coin of gold of the denomination of ten pounds shall be made, being a coin of a standard weight of 156.295 grammes, a standard diameter of 50 millimetres, a millesimal fineness of not less than 999, and being circular in shape.

(2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

- (a) a variation from the said standard weight of an amount per coin of 0.783 grammes; and
- (b) a variation from the said standard diameter of 0.125 millimetres per coin
- (3) The least current weight of the said gold coin shall be 154.5 grammes.
- (4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of coins.
- (5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription "- ELIZABETH II · D · G · REG · F · D · 10 POUNDS" and for the reverse a depiction of William Shakespeare accompanied with the inscription "OTHELLO ACTI SC.3" surrounded by the inscription " · PUT MONEY IN THY PURSE · 2016". The coin will have a graining upon the edge.'

SILVER COIN

2. (1) A new coin of silver of the denomination of ten pounds shall be made, being a coin of a standard weight of 156.295 grammes, a standard diameter of 65 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.

(2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.783 grammes; and

- (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogramme of coins.
- (4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription "- ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 10 POUNDS" and for the reverse a depiction of William Shakespeare accompanied with the inscription "OTHELLO ACTI SC.3" surrounded by the inscription " \cdot PUT MONEY IN THY PURSE \cdot 2016". The coin will have a graining upon the edge.'

- (5) The said silver coin shall be legal tender for payment of any amount in any part of Our United Kingdom.
- 3. This Proclamation shall come into force on the eleventh day of February Two thousand and sixteen.

BY THE QUEEN A PROCLAMATION DETERMINING THE SPECIFICATIONS AND DESIGN FOR A NEW ONE POUND COIN FUZABETH R

Whereas under section 3(1)(a), (b), (cc), (cd), (d) and (dd) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to determine the denomination, the design and dimensions of coins to be made at Our Mint, to determine the weight and composition of coins other than gold coins or coins of silver of Our Maundy money and the remedy to be allowed in the making of such coins, to provide for the manner of measurement of the variation from the standard weight of coins, and to determine the percentage of impurities which such coins may contain:

And Whereas under section 3(1)(f) and (ff) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to direct that coins made at Our Mint other than gold, silver, cupronickel and bronze coins shall be current and that any coin shall be legal tender for the payment of any amount:

And Whereas it appears to Us desirable to order that there should be made at Our Mint coins of the denomination of one pound in nickel-brass, having joined concentric inner and outer sections, with a nickel plated inner section and a nickel-brass outer section:

We, therefore, in pursuance of the said section 3(1)(a), (b), (cc), (cd), (d), (dd), (f) and (ff), and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

NICKEL-BRASS COIN

- 1. (1) A new coin of nickel-brass of the denomination of one pound shall be made, being a coin of a standard weight (including the nickel plate) of 8.75 grammes, a standard diameter of 23.03 millimetres, being twelve sided in shape and having joined concentric inner and outer sections, with a standard composition (excluding the nickel plate) of seventy-six per centum copper, four per centum nickel and twenty per centum zinc.
- (2) In the making of the said nickel-brass coin a remedy (that is, a variation from the standard weight, composition or dimensions specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.3 grammes for the inner and outer sections;
- (b) in relation to those parts of the coin other than the nickel plating, a variation from the said standard composition of two per centum copper, three-quarters of one per centum nickel and two per centum zinc; and
- (c) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The said nickel-brass coin shall be current and shall be legal tender for the payment of any amount in any part of Our United Kingdom.

DESIGN OF THE COIN

2. The design of the said coin shall be as follows:

'For the obverse impression Our effigy with inscription "· ELIZABETH II · D · G · REG · F · D $\mathfrak L1$ ", and the date of the year. For the reverse a depiction of a rose, leek, thistle and shamrock encircled by and emerging from a crown with the inscription "ONE POUND" below. The said coin will have alternate grained and plain edges.'

3. This Proclamation shall come into force on the eleventh day of February Two thousand and sixteen.

Whereas under section 3(1)(a), (b), (c), (cc), (cd) and (d) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to determine the denomination, the design and dimensions of coins to be made at Our Mint, to determine the weight and fineness of certain gold coins, the remedy to be allowed in the making of such coins and the least current weight, and to determine the weight and composition of coins other than gold coins or coins of silver of Our Maundy money and the remedy to be allowed in the making of such coins, and to provide for the manner of measurement of the variation from the standard weight of coins:

And Whereas under section 3(1)(ff) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to direct that any coin shall be legal tender for the payment of any amount:

And Whereas it appears to Us desirable to order that there should be made at Our Mint a new series of coins of the denominations of one hundred pounds and twenty-five pounds in gold and five pounds in silver:

We, therefore, in pursuance of the said section 3(1)(a), (b), (c), (cc), (cd), (d) and (ff), and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

ONE HUNDRED POUND COIN

- 1. (1) A new coin of gold of the denomination of one hundred pounds shall be made, being a coin of a standard weight of 31.210 grammes, a standard diameter of 32.690 millimetres, a millesimal fineness of not less than 999.9, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter, specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.105 grammes; and
- (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
- (4) The least current weight of the said gold coin shall be 31.010 grammes.
- (5) The design of the said gold coin shall be as follows:

For the obverse impression Our effigy with the inscription "- ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 100 POUNDS", and for the reverse a lion accompanied by a shield depicting Our Royal Arms with the inscription "FINE GOLD \cdot 999.9 \cdot 2016 LION OF ENGLAND \cdot 10Z" . The coin will have a grained edge.'

TWENTY-FIVE POUND COIN

- 2. (1) A new coin of gold of the denomination of twenty-five pounds shall be made, being a coin of a standard weight of 7.800 grammes, a standard diameter of 22 millimetres, a millesimal fineness of not more than 999.9, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.025 grammes; and
- (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
- (4) The least current weight of the said gold coin shall be 7.750 grammes.
- (5) The design of the said gold coin shall be as follows:
- 'For the obverse impression Our effigy with the inscription "-ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 25 POUNDS", and for the reverse a lion accompanied by a shield depicting Our Royal Arms with the inscription "FINE GOLD \cdot 999.9 \cdot 2016 LION OF ENGLAND \cdot 1/40Z" . The coin will have a grained edge.'

FIVE POUND COIN

3. (1) A new coin of silver of the denomination of five pounds shall be made, being a coin of a standard weight of 62.420 grammes, a standard diameter of 38.61 millimetres, a standard composition of not less than 999.9 parts per thousand fine silver, and being circular in shape.

- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight, diameter or composition specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.195 grammes; and
- (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of coins.

(4) The design of the said silver coin shall be as follows:

- 'For the obverse impression Our effigy with the inscription "-ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 5 POUNDS", and for the reverse a lion accompanied by a shield depicting Our Royal Arms with the inscription "FINE SILVER \cdot 999.9 \cdot 2016 LION OF ENGLAND \cdot 20Z" . The coin will have a grained edge.'
- (5) The said silver coin shall be legal tender for payment of any amount in any part of Our United Kingdom.
- 4. This Proclamation shall come into force on the eleventh day of February Two thousand and sixteen.

MISUSE OF DRUGS ACT 1971

THE MISUSE OF DRUGS (AMENDMENT) REGULATIONS (NORTHERN IRELAND) 2016 (SR 2016 NO. 29)

The Department of Health, Social Services and Public Safety has made a Statutory Rule entitled 'The Misuse of Drugs (Amendment) Regulations (Northern Ireland) 2016, (SR 2016 No. 29), which comes into operation on 1 March 2016.

These Regulations amend the Misuse of Drugs Regulations (Northern Ireland) 2002, (the "2002 Regulations") by including within the definition of "health prescription" contained in regulation 2(1) of the 2002 Regulations a nurse independent prescriber, a pharmacist independent prescriber, and a supplementary prescriber as persons who may issue such a prescription.

Regulation 8 is amended to exempt ketamine from the restrictions on supplying or offering to supply controlled drugs, where this is done by specified healthcare professionals in accordance with the terms of a Patient Group Direction, except where the drug is administered for the purposes of treating addiction.

Regulations 15 and 16 of the 2002 Regulations are amended by removing references to temazepam, so that it is no longer exempt from the requirements relating to the form of prescriptions.

Ketamine is moved from Part 1 of Schedule 4 to Schedule 2 to the 2002 Regulations. The heading of Schedule 3 is amended to remove the reference to temazepam being exempt from the requirements of regulation 15 of the 2002 Regulations. The schedule of the Regulations in which a controlled drug is placed affects the extent to which the drug can be lawfully imported, exported, produced, supplied or possessed. The controlled drugs placed in Schedule 1 to the Regulations are those subject to the tightest controls.

Both parties agree (including on behalf of any principal, if applicable) that this shall be the sole remedy of the Advertiser (including any principal, if applicable) and full extent of the limit of the Publishers liability in these circumstances.
