ROAD AND RAILWAY TRANSPORT ACT (NORTHERN IRELAND), 1935.

Order made by the Minister of Home Affairs under Section 14 of the Road and Railway Transport Act (Northern Ireland), 1935, extending the period within which the scheme for Pooling Receipts of the Northern Ireland Road Transport Board and the Railway Companies may be prepared.

I, the Right Honourable Sir Richard Dawson Bates, Minister of Home Affairs for Northern Ireland, in pursuance of the powers vested in me by Section 14 of the Road and Railway Transport Act (Northern Ireland), 1935 (in this Order referred to as "the Act"), and of all other powers in that behalf enabling me, but without prejudice to any further exercise of such powers, hereby order and direct that the period within which the Joint Committee estab-

lished under the aforesaid section shall prepare and submit to the Northern Ireland Transport Board and to each of the Railway Companies mentioned in said section the pooling scheme framed in accordance with the provisions of the First Schedule to the Act shall be further extended to the 15th day of January, 1937:

The Civil Service Commissioners for Northern Ireland hereby give notice that the following Regulations are published with the approval of the Ministry of Finance for Northern Ireland, and, in so far as they apply to appointments in the County Court Service, with the concurrence of the Ministry of Home Affairs for Northern Ireland.

REGULATIONS RESPECTING OPEN COMPETITIONS FOR THE SITUATION OF CLERK (MALE) IN THE CIVIL SERVICE.

- 1. The limits of age are 18 and 20. If a competition begins in one of the first six months of any year, candidates must be of or over the age of 18 and under the age of 20 on the 31st day of March in that year. If a competition begins in one of the last six months of the year, candidates must be of or over the age of 18 and under the age of 20 on the 30th day of September in that year.
- 2. Every candidate must be a naturalborn British subject, the child of a person who is or was at the time of death a British subject; provided that if the Civil Service Commissioners are satisfied in the case of any candidate who is a British subject but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate is so closely connected by ancestry and upbringing with His Majesty's Dominions that an exception may properly be made to that rule, they may accept such candidate as eligible provided that this discretion shall not be exercisable unless (a) the father or the paternal grandfather of the candidate was a natural-born British subject, and (b) neither the father nor the paternal grandfather had acquired any other nationality by naturalization or by any other voluntary and formal act.
- 3. Persons upon whose training for the occupation of teacher public money has been spent, cannot be appointed until the consent of the Ministry of Finance has been notified to the Civil Service Commissioners.

Part of the examinations in Physics and Chemistry will be practical, and part of the examinations in French, German and Spanish will be oral. The practical and oral examinations will be held either during the course of the written examinations or immediately before or after them.

All the subjects in Part I. must be taken, and candidates may also offer subjects in Part II. aggregating marks up to, but not exceeding, a total of 1,100.
