BY THE QUEEN A PROCLAMATION FOR DECLARING THE CALLING OF A NEW PARLIAMENT ELIZABETH R.

Whereas We, by and with the advice of Our Privy Council, being desirous and resolved, as soon as may be, to meet Our People, and to have their Advice in Parliament, do publish this, Our Royal Proclamation, and do hereby make known to all Our loving Subjects Our Royal Will and Pleasure to call a new Parliament to be holden at Westminster on Tuesday the thirteenth day of June next: And We do hereby also, by this Our Royal Proclamation under Our Great Seal of Our Realm, require Writs to be issued by Our Chancellor of Great Britain for causing the Lords Spiritual and Temporal who are to serve in the said Parliament to give their Attendance in Our said Parliament on the said date.

Given at Our Court at Buckingham Palace, this third day of May in the Year of our Lord two thousand and seventeen and in the sixty-sixth year of Our Reign.

BY THE QUEEN A PROCLAMATION DETERMINING THE SPECIFICATIONS AND DESIGN FOR A NEW PIEDFORT SOVEREIGN ELIZABETH R.

Whereas under section 3(1)(a), (b), (c), (cd) and (d) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to determine the denomination, the design and dimensions of coins to be made at Our Mint, to determine the weight and fineness of certain gold coins, the remedy to be allowed in the making of such coins and their least current weight, and to provide for the manner of measurement of the variation from the standard weight of coins:

And Whereas it appears to Us desirable to order that there should be made at Our Mint a new coin of the denomination of one pound in gold:

We, therefore, in pursuance of the said section 3(1)(a), (b), (c), (cd) and (d), and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

PIEDFORT SOVEREIGN

- 1. (1) A new coin of gold of the denomination of one pound shall be made, being a coin of a standard weight of 15.976 grammes, a standard diameter of 22.05 millimetres, a millesimal fineness of not more than 916.7, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.030 grammes;
- (b) a variation from the said standard diameter of 0.125 millimetres per coin; and
- (c) a variation from the said millesimal fineness of two per mille.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
- (4) The least current weight of the said gold coin shall be 15.946 grammes.
- (5) The design of the said gold coin shall be as follows:
- 'For the obverse impression Our effigy with the inscription "- ELIZABETH II \cdot DEI \cdot GRA \cdot REG \cdot FID \cdot DEF \cdot 2017", and for the reverse the image of St George armed, sitting on horseback, attacking the dragon with a broken spear surrounded by the inscription "HONI \cdot SOIT \cdot QUI \cdot MAL \cdot Y \cdot PENSE \cdot ". The coin shall have a grained edge.'
- 2. This Proclamation shall come into force on the fourth day of May Two thousand and seventeen.

Whereas under section 3(1)(a), (b), (c), (cc), (cd) and (d) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to determine the denomination, the design and dimensions of coins to be made at Our Mint, to determine the weight and fineness of certain gold coins, the remedy to be allowed in the making of such coins and their least current weight, and to determine the weight and composition of coins other than gold coins or coins of silver of Our Maundy money, and the remedy to be allowed in the making of such coins, and to provide for the manner of measurement of the variation from the standard weight of coins:

And Whereas under section 3(1)(ff) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to direct that any coin shall be legal tender for the payment of any amount:

And Whereas it appears to Us desirable to order that there should be made at Our Mint a new series of coins of the denominations of one thousand pounds, five hundred pounds, one hundred pounds, and twenty-five pounds in gold, and a new series of coins of the denominations of five hundred pounds, ten pounds and two pounds in silver:

We, therefore, in pursuance of the said section 3(1)(a), (b), (c), (cc), (cd), (d) and (ff), and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

ONE THOUSAND POUND COIN

- 1. (1) A new coin of gold of the denomination of one thousand pounds shall be made, being a coin of a standard weight of 1005 grammes, a standard diameter of 100 millimetres, a millesimal fineness of not less than 999, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 5 grammes; and
- (b) a variation from the said standard diameter of 0.25 millimetres per coin.
- (3) The variation from the standard weight will be measured by weighing each coin separately.
- (4) The least current weight of the said gold coin shall be 995 grammes.
- (5) The design of the said gold coin shall be as follows:
- For the obverse impression Our effigy with the inscription "- ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 1000 POUNDS", and for the reverse a rearing unicorn accompanied by a shield depicting a lion rampant with the inscription "- UNICORN OF SCOTLAND ·" and the date of the year. The coin shall have a grained edge.'

FIVE HUNDRED POUND COIN

- 2. (1) A new coin of gold of the denomination of five hundred pounds shall be made, being a coin of a standard weight of 156.295 grammes, a standard diameter of 50 millimetres, a millesimal fineness of not less than 999.9, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.8 grammes; and
- (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
- (4) The least current weight of the said gold coin shall be 154.500 grammes.
- (5) The design of the said gold coin shall be as follows:
- 'For the obverse impression Our effigy with the inscription "- ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 500 POUNDS", and for the reverse a rearing unicorn accompanied by a shield depicting a lion rampant with the inscription "- UNICORN OF SCOTLAND ·" and the date of the year. The coin shall have a grained edge.'

ONE HUNDRED POUND COIN

- 3. (1) A new coin of gold of the denomination of one hundred pounds shall be made, being a coin of a standard weight of 31.210 grammes, a standard diameter of 32.69 millimetres, a millesimal fineness of not less than 999.9, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.15 grammes; and
- (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
- (4) The least current weight of the said gold coin shall be 31.010 grammes.
- (5) The design of the said gold coin shall be as follows:

- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.025 grammes; and
- (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
- (4) The least current weight of the said gold coin shall be 7.750 grammes.
- (5) The design of the said gold coin shall be as follows:

- 5. (1) A new coin of silver of the denomination of five hundred pounds shall be made, being a coin of a standard weight of 1005 grammes, a standard diameter of 100 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 5 grammes; and
- (b) a variation from the said standard diameter of 0.25 millimetres per coin.
- (3) The variation from the standard weight will be measured by weighing each coin separately.
- (4) The design of the said silver coin shall be as follows:
- For the obverse impression Our effigy with the inscription "- ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 500 POUNDS", and for the reverse a rearing unicorn accompanied by a shield depicting a lion rampant with the inscription "- UNICORN OF SCOTLAND \cdot " and the date of the year. TEN POUND COIN

- 6. (1) A new coin of silver of the denomination of ten pounds shall be made, being a coin of a standard weight of 156.295 grammes, a standard diameter of 65 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.85 grammes; and

- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
- (4) The design of the said silver coin shall be as follows:
- 'For the obverse impression Our effigy with the inscription "- ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 10 POUNDS", and for the reverse a rearing unicorn accompanied by a shield depicting a lion rampant with the inscription "- UNICORN OF SCOTLAND ·" and the date of the year. - (a) a variation from the said standard weight of an amount per coin of 1.75 grammes; and
- (b) a variation from the said standard diameter of 0.125 millimetres per
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.15 grammes; and
- (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
- (4) The design of the said silver coin shall be as follows:
