The following Letter Patent was signed by Her Majesty The Queen on the 17 April 2018 in respect of the Offensive Behaviour at Football and Threatening Communications (Repeal) (Scotland) Bill ASP 7.

ELIZABETH THE SECOND by the Grace of God of the United Kingdom of Great Britain and Northern Ireland and of Our other Realms and Territories Queen Head of the Commonwealth Defender of the Faith To Our trusty and well beloved the members of the Scottish Parliament

GREETING:

FORASMUCH as a Bill has been passed by the Scottish Parliament and has been submitted to Us for Our Royal Assent by the Presiding Officer of the Scottish Parliament in accordance with the Scotland Act 1998 the short Title of which Bill is set forth in the Schedule hereto but that Bill by virtue of the Scotland Act 1998 does not become an Act of the Scottish Parliament nor have effect in the Law without Our Royal Assent signified by Letters Patent under Our Scottish Seal (that is Our Seal appointed by the Treaty of Union to be kept and used in Scotland in place of the Great Seal of Scotland) signed with Our own hand and recorded in the Register of the Great Seal We have therefore caused these Our Letters Patent to be made and have signed them and by them do give Our Royal Assent to that Bill COMMANDING ALSO the Keeper of Our Scottish Seal to seal these Our Letters with that Seal.

PLANNING ACT (NORTHERN IRELAND) 2011 THE PLANNING (STATEMENT OF COMMUNITY INVOLVEMENT) REGULATIONS (NORTHERN IRELAND) 2015 REVISED STATEMENT OF COMMUNITY INVOLVEMENT

Section 4 of the Planning Act (Northern Ireland) 2011 places a statutory duty on Councils to prepare a Statement of Community Involvement (SCI) which sets out how and when stakeholders and other interested parties will be consulted and involved in the preparation of the Local Development Plan (LDP), as well in Development Management.

The Department for Infrastructure has made a Statutory Rule entitled "The Public Service Vehicles (Amendment) Regulations (Northern Ireland) 2018 (S.R. 2018 No. 89), which comes into operation 20th May 2018.

This Rule amends the Public Service Vehicles Regulations (Northern Ireland) 1985 ("the 1985 Regulations") to give effect to the requirements of Directive 2014/45/EU of the European Parliament and of the Council of 3rd April 2014 on the periodic roadworthiness tests for motor vehicles and their trailer.

These Regulations amend regulation 9 (re-inspection of vehicle) of the 1985 Regulations to prescribe a limit on the time for retesting follow an initial test failure.

These Regulations also amend Schedule 3 (items included in inspection) of the 1985 Regulations to include reference to front fog lamps, reversing lamps and daytime running lamps as items to be inspected.

DEPARTMENT FOR INFRASTRUCTURE THE ROAD VEHICLES LIGHTING (AMENDMENT) REGULATIONS (NORTHERN IRELAND) 2018

The Department for Infrastructure has made a Statutory Rule entitled "The Road Vehicles Lighting Amendment) Regulations (Northern Ireland) 2018 (S.R. 2018 No. 88), which comes into operation 20th May 2018.

This rule amends the Road Vehicle Lighting Regulations (Northern Ireland) 2000 ("the 2000 Regulations") to make provision about the fitting and maintenance of lighting equipment for motor vehicles and trailers used on roads. These Regulations amend the 2000 Regulations to give effect to the requirements of Article 6 of Directive 2014/45/EU of the European Parliament and of the Council of 3 April 2014 on periodic road worthiness tests for motor vehicles and their trailers.

These Regulations amend the 2000 Regulations to insert new references to adaptive front lighting systems, daytime running lamps, headlamp cleaning devices, reversing lamps and front fog lamps.

THE DEPARTMENT FOR INFRASTRUCTURE THE TAXI LICENSING (AMENDMENT) REGULATIONS (NORTHERN IRELAND) 2018

The Department for Infrastructure has made a Statutory Rule entitled "The Taxi Licensing (Amendment) Regulations (Northern Ireland) 2018 (S.R. 2018 No. 90), which comes into operation 20th May 2018.

This Rule amends the Taxi Licensing Regulations (Northern Ireland) 2015 ("the 2015 Regulations") to give effect to the requirements of Directive 2014/45/EU of the European Parliament and of the Council of 3rd April 2014 on the periodic roadworthiness tests for motor vehicles and their trailers. These Regulations amend regulation 9 (further application for a taxi licence) of the 2015 Regulations to prescribe a limit on the time allowed for retesting following an initial test failure.

They also amend Schedule 2 (item included in inspection) of the 2015 Regulations to include front fog lamps, reversing lamps and daytime running lamps as items to be inspected under regulation 4 (inspection of taxi) of the 2015 Regulations.

DEPARTMENT OF JUSTICE ORDER UNDER SECTION 32 OF THE JUSTICE AND SECURITY (NORTHERN IRELAND) ACT 2007

The Secretary of State and the Department of Justice have entered into Agency Arrangements under section 28 of the Northern Ireland Act 1998 under which the functions of the Secretary of State, under section 32 of the Justice and Security (Northern Ireland) Act 2007, may be exercised by the Department of Justice provided such exercise does not affect any excepted or reserved matters other than incidentally.

The Department of Justice, acting under those arrangements, considers it necessary for the preservation of the peace and the maintenance of order to make the following Order in exercise of the powers contained in section 32 of the Justice and Security (Northern Ireland) Act 2007.

The Department of Justice by Order directs that the alleyways adjacent to Lisbon Street, East Belfast, delineated in red on the attached map, be closed with gates at the points marked as "A", "B", and "C", to all vehicles (including, but not limited to, motorbikes, bicycles and riders on horseback) and pedestrian traffic.

This order does not apply to the following persons, or vehicles being used by them:

1. Members of the Police Service of Northern Ireland, the Northern Ireland Fire and Rescue Service, medical practitioners, paramedics, nurses and midwives who are on duty; and
2. Any person who requires access to this road for the purpose of maintaining public safety, public utilities (including, but not limited to, gas pipes, water mains, telephone lines, and electricity cables) and has been given permission to enter by a member of the Police Service of Northern Ireland who is on duty.

This order shall come into force at 00.00 hours on 12 April 2018.

DEPARTMENT OF JUSTICE AUTHORISATION FOR REVOCATION UNDER SECTION 29 OF THE JUSTICE AND SECURITY (NORTHERN IRELAND) ACT 2007 CONCERNING LAND BETWEEN CURRAN STREET AND NORTH WAY IN PORTADOWN

These Regulations amend regulation 3 of, and Schedule 2 to, the 2003 Regulations to bring certain category "N" vehicles, certain category "O" trailers and certain motor tractors within the scope of the 2003 Regulations. New exemptions have been created for vehicles with a maximum design speed of less than 15.5 mph, showman's vehicles and certain purpose built mobile machinery.

The Regulations also amend Schedule 3 of the 2003 Regulations to prescribe additional testing requirements in relation to front fog lamps and reversing lamps and steering locks.

These Regulations amend regulation 13 of the 2003 Regulations to prescribe a limit on the time allowed for retesting follow an initial test failure.


